### **Mock Trial**

Friday, May 30, 2014, Mrs. Dahn, the gifted/gems elementary teacher in our school district, brought her 5th grade gifted class to the courtroom for a mock trial. The students participated as jurors, witnesses and attorneys in the case of the Commonwealth v. Jeremiah Birch with yours truly presiding as judge.

Mr. Birch was accused of aggravated battery. The exercise was designed with no clear winner in mind. There were facts that supported both the prosecution and the defense. The mock trial was conducted as close to the real thing as you can get, with the students presenting opening statements, direct testimony, cross examination and closing arguments. After receiving instructions from the court, the jury deliberated. It was not an easy decision nor was it unanimous, but the jury acquitted Mr. Birch, returning a verdict of not guilty.

I would like to congratulate Mrs. Dahn on all the hard work and preparation she put into the exercise. It all came together and was evident in the excellent job the students did in presenting their cases. It was truly a pleasure and honor to conduct the trial. I hope the students left with a greater appreciation for our jury system. I enjoyed presiding over the trial and Mrs. Dahn and her students are welcome back anytime.





# SUPERVISOR'S CORNER =

Hello all, we recently had our residents weekend at Picnicana and every thing went well. The rain stayed away too. The summer camp program went well and hopefully all who take advantage of this program enjoyed it. We finished laying out our public trails at the park and the FLB cross country track team has held a couple of work parties to clean the trails. They will be using them this fall for their home track meets.

In the next couple of months, we will have lighting installed in the two picnic shelters. At the ball fields we are going to have the snack bar or press box sided and one outdoor drinking fountain installed. We have had a very wet year but summer keeps moving on.

The Roar on the Shore opened up with the kick off ride through Summit and that went well too. Our young grounds keepers do a great job of cleaning and landscaping. I hope we have a good long mild fall because we have it coming.

Remember please, we have a very populated and still growing township. Please be patient and kind with our zoning office. Their work is important and zoning regulations are made to protect the majority of the residents. Without ordinances and zoning regulations a busy township like ours would be in chaos.

On the roads, our crews have been cleaning ditches, installing storm sewers, patching roads, replacing signs, and recently replaced a 36" culvert on Hamot road. The road was only closed for less than three days and once again the weather did not cooperate. They finished this project and did a great job. Thank you road crew. Recently we opened Frank with a four way stop sign at the intersection of Glenmar. We are doing this for a four week period to study how the traffic flow works and to monitor any kind of problems that may need addressed. Many pros and cons, and many local residents want it open to be able to access Route 97 at the Frank avenue traffic light. One more item we are waiting to see completed is the intersection at the west end of Townhall road and Route 19. This is a PA DOT project and will be much safer when finished. Again, please drive careful and be patient. Looking forward to a pleasant fall.

As Treasurer for Summit Township, it gives me great pleasure to inform all of you that our new municipal building was completely paid off last month, just one year after we moved in! In addition, we remain in a very sound financial position with funds in our Capital Improvement, Capital Reserve and Operating Reserve accounts totaling \$4,477,976.38 (as of 7/31/14). Keeping in mind that this amount fluctuates and that major capital improvements can be very expensive; we continue to be very conservative with our funds. The ultimate goal is to protect the stability of Summit Township into the future, should our funding sources (i.e. Presque Isle Downs and Lakeview Landfill) be reduced or cease to exist at any given time.

The \$5.8 million investment in our municipal building is already paying great dividends. Construction of our History Room and development of the Emergency Management Office are well underway thanks to our outstanding volunteers (we can always use more!). We've had a tremendous turnout for our open house, two art shows and receptions. Our conference rooms, public meeting room and lunchroom have accommodated a wide variety of meetings; including our local boards and authorities, homeowner's associations, Lions Club, Erie Area Council of Governments, Erie Metropolitan Planning Organization, Zoning Association and many others. We have also been able to hold on-site training sessions and facilitate art classes. The potential of our building is just starting to be tapped into and we are certain it will serve Summit Township well for the next 50-100 years.

It's nice to see community events really catching on out here in Summit. I've watched our Senior Picnic grow to park capacity, our Art Show has become an annual event (thanks to Downia Glass and Catherine Caufield) and Resident Days saw larger numbers than ever enjoying all the food, festivities and a movie under the stars. I'm very proud and grateful to be part of such a wonderful community.

I don't know about all of you, but I'm not sure where the summer went. Here's hoping you enjoy what's left and that we get some great weather this fall!

### FROM YOUR SUMMIT TAX COLLECTOR:

Hello to Everyone!

It's hard to believe, but summer (where did it go? is it coming back?) is coming to an end. Hope everyone had a great one regardless.

Mills remained the same for County-Township and School for 2014. You will see approximately a .04 reduction in your School taxes if you have the Homestead Exclusion as the exclusion was increased from \$178.17 to \$178.21 this year.

At the time of this printing, the 2014 C-T tax bills are now in the 10% Penalty phase. Interims issued 1-1-14, B13-2013 are now also in the Penalty phase.

The 2014/2015 School bills are in the last phase of Discount which ends August 31, 2014. Interims issued January 1, 2014, C13-2013 and A14-2014 are in the Discount phase until 8/31/14. A word of advice - if you have an Interim tax bill and forwarded on to your mortgage company, please check to make sure they have paid it. I will be happy to look it up here first, just call me during normal business hours. Not all mortgage companies pay Interim tax bills. Every year I see Interims that are not paid and the homeowner receives a final notice in November and assumed the mortgage company paid their Interim. The mortgage companies do not notify you that they are not paying.

### PLEASE NOTE THE PARAGRAPH BELOW:

As this year the 31st falls on a Sunday and the Labor Day weekend, Thursday, August 28th will be the last date I will be open before the 31st. If you are paying by cash or wish to come into the office to pay, please remember the date. You may use the locked mailbox to the right of the office door at anytime through the 31st. Enclose a S.A.S.E. if you want a receipt sent. If sending via US mail, postdate MUST be August 31st to be accepted at Discount.

The Homestead Exclusion remains in effect as long as the State continues to provide this exclusion and you DO NOT have to reapply every year. Once you move from your current home that has the exclusion, the new owners must apply and you will too if your new home is in Pennsylvania.

### **SUMMIT TOWNSHIP SEWER AUTHORITY**

Sanitary Sewer Extension Project 2010: Proctor, Merle, Melvin, Dorn and New Roads

All of the construction is complete and the Summit Township Sewer Authority (STSA) has issued the official Connection Notices in the three project areas. We are pleased to report that the cost per home remains \$7,500 for existing homes.

The contractors have completed all of the restoration and the STSA is fielding calls regarding customers concerns with any outstanding work. Please bear in mind, no project goes off "without a hitch" so customers should know that if they are not satisfied with the restoration they need to call the Authority office. In my opinion, overall, the contactors did a good job interacting with staff, inspectors and the public. While we are compelled by law to accept the lowest responsible bidder the workmanship has certainly met or exceeded our expectations. We again want to thank the Summit Township Residents in the project areas for their cooperation and support with making this project successful.

The STSA has been working on a large scale lift station project serving the Route 97 corridor south of I-90. This will be our largest project in the last 20 years with an estimated value of \$3.5 million dollars. The project involves the replacement of our largest lift station. The design will address the future pumping needs of the Route 97 corridor. In engineering terms we are looking at the "ultimate design". This means we have looked at the sewerage needs for normal complete development given the current zoning established in the township. We expect to receive bids on the work in the spring of 2015 and we believe it will be complete in about 12 months.

If any sewer customer has any questions or concerns, please feel free to call the Authority at 868-4495 or attend a monthly meeting. Check your Township calendar for Sewer Authority meeting dates, (generally the last Thursday of the month, except November and December are one week earlier). The Authority hours are 8:00 AM - Noon and 12:30 - 4:30 PM, Monday through Friday. If you plan to attend a meeting, please call and let us know.


Amber and Julie want to thank the community for all their support and help over the years. They couldn't have done it without all the help and support from their fellow Summit Township Residents.
