### **Mock Trial**

Tuesday, May 26, 2015, we once again welcomed Mrs. Dahn and her 5th grade gifted students to the courtroom for a mock trial. The students participated as jurors, witnesses and attorneys in the case of the *Commonwealth v. Hansel Schmidt and Gretel Schmidt* with yours truly presiding as judge.

The Schmidts were charged with aggravated battery, criminal mischief and petit theft. The exercise was designed with no clear winner in mind. There were facts that supported both the prosecution and the defense. The mock trial was conducted as close to the real thing as you can get, with the students presenting opening statements, direct testimony, cross examination and closing arguments. After receiving instructions from the court, the jury deliberated. Mrs. Dahn and I participated with but did not influence or vote with the jury.

I would like to congratulate Mrs. Dahn on all the hard work and preparation she put into the exercise. It all came together and was evident in the excellent job the students did in presenting their cases. It was truly a pleasure and honor to conduct the trial. I hope the students left with a greater appreciation for our jury system. I enjoyed presiding over the trial and Mrs. Dahn and her students are always welcome back.





Hello all, as everyone knows, we had a very wet spring. That set back many construction projects and road work. We are finally catching up on road maintenance and repairs. Line painting has begun. The roads that have not been seal coated or tar and chipped this year will soon receive crack filler and chip to help seal and maintain them before winter. We are fortunate to have enough money and equipment to keep our roads in good condition. In my opinion, Summit has some of the best roads in Erie County. Because of our growing Township and busy roads, PA Dot has been surveying and studying the intersections of Route 99, Hamot Road, and Hershey road for future renovations to help the traffic flow. Route 99 and Hershey road are both state roads. We've not heard exactly what changes will be made, but I will pass that information on as soon as available. PA Dot has also posted many approaching roads to Robison and Oliver roads with orange triangle signs that say, "fresh oil and chip" and the others saying, "no pavement markings." I believe these were put up by the state as they prepare to seal coat Robison and Oliver roads (also state roads).

Our parks are doing well and have been very busy. The Township keeps taking steps to improve them. Currently, we are planning on expanding Picnicana's parking lot to the south. During many events, we have run out of parking spaces (residents weekend and the senior picnic were both well attended). People had to park along the side of the road and in the grass.

Thanks to Pat and her crew for doing such a great job with the kids summer program. They make it happen and what a great way to keep the kids busy

and active for the summer months. They also have an opportunity to go on four field trips as part of the program.

The ball fields have been very active too. Plans are in the works to put a fence up between the township construction yard and the ball fields; so kids will not wander off and take a chance of getting hurt while playing around equipment and material - where they do not belong!

We are a prosperous and busy township and hardly a rural area anymore. Our township now maintains 14 traffic lights and the majority of them are multiple lanes. This also makes zoning difficult. For every action, you will have a reaction. I like to support businesses who provide people the opportunity of having a job but I also want to protect the privacy of residential areas. This is a hard balance to try and keep all parties happy and causes ordinances that are easily criticized but are in place to help protect people and their neighborhoods. I am a sportsmen and love the outdoors. I support State and National forests. I am not crazy about expansion, cutting down old wooded areas, or developing what was once farm land; but you have to compromise and respect developers and land owners rights too. Without laws and ordinances, we would be living in chaos. I bring this up because I receive many phone calls about issues and complaints over which I may have little control, but as part of my job, I discuss the issue, look at legal limits, and make the best decision I can.

### RESIDENTIAL FUND DRIVE IN FULL SWING

The residential fund drive to support your local volunteer Fire and Ambulance Company has been under

way for several weeks at this point. The first letters went out in the last week of April to kick off the 2015 residential campaign. The second mailer postcards were sent out the 2nd week of July to the residents who have not yet donated. We are still accepting donations for the 2015 Fund drive.

As of this article, just over 1/3 of the residents (34%) have donated to this year's request for a donation to support your ambulance service and fire department. Perry Hi-Way Hose Company is not supported by taxes. The township does provide \$5000/year toward our operational costs, but the total operating budget for the year is over \$250,000. This doesn't include any money to be used to replace trucks and equipment as it wears out. We must rely on the businesses and residents to support the services we provide. The Business Fund drive began January 1, 2015 with similar results of only 39% of Summit businesses donating for 2015.





### **SUMMIT TOWNSHIP SEWER AUTHORITY**

#### **NOTICE OF RATE INCREASE**

The Summit Township Sewer Authority (STSA) will be increasing the sewer rates. The Authority Board has approved a \$2.00 per month increase for residential customers. The residential sewer rate will increase to \$81.00 per quarter up from \$75.00 per quarter. For low flow commercial customers the rate increases from \$4.29/1,000 gallons to \$4.63/1,000 gallons. For high flow commercial customers the rate increases from \$4.86/1,000 gallons to \$5.25/1,000 gallons. The new rate will be reflected in the September 2015 billing.

There are many factors that contribute to the need for this rate increase; the most significant factor is the cost of replacing the existing Holiday Inn lift station. The existing pump station serves lands in Summit Township south of I-90 and along Route 97. The Holiday Inn Pump Station is 32 years old and does not have adequate capacity for the projected future loads. It is not feasible to upgrade the existing station to meet the projected ultimate demand as there is insufficient land on the existing site to expand the pump station. Without the additional capacity that the new pump station will provide the Township would face a moratorium on new development in the Route 97 corridor.

The project is estimated to cost a total of \$3,600,000. The Authority did receive a grant from the Summit Township Industrial and Economic Development Authority (STIEDA) for \$1,304,860. However, the Authority expects to borrow an additional \$1,200,000 and the balance will come from capital reserves. Furthermore, the Meadows and Oliver Road Lift Stations are in need of replacement and upgrades and we believe we will be able to address these project expenses without an additional rate increase.

We have made every effort to offset the needed increase. We have already restructured existing STSA debts and continue spend down cash reserves as deemed appropriate. We worked diligently to get a significant grant from STIE-DA for the Route 97 Project. Even after all of these positive efforts, we are still left with a shortfall and had no choice but to increase our current rates in order to balance the current budget and maintain an efficient and economical system.

Lastly, please bear in mind the STSA still has the lowest rate of the satellite municipalities connected to the City of Erie Joint Transportation System and you may recall the STSA has not raised rates since 2011. We are committed to providing you quality service at the best rates possible.

### FROM YOUR SUMMIT TAX COLLECTOR:

Happy summer to all!

The 2015/2016 School taxes were mailed on June 30, 2015. If you have not received your tax bill, please contact me. Eric County Assessment will send your bill to the last known address you provided to them. This is especially important if you had a home built and were living elsewhere why it was being built. I cannot change the address for you. I can however, provide you with the form to do so. Once filled out, the form is returned to Eric County Assessment for update. Eric County Assessment requires this form to be on file. The school mills increased from 11.39 to 11.65 and the Homestead Exclusion for this year is \$176.63. The Homestead Exclusion DOES NOT apply to Interim tax bills, only the regular tax bills in cycle.

2015 County-Township bills are now in the 10% Penalty phase. Interims issued January 1, 2015 (if applicable) are also now in the Penalty phase. If you have sent any Interim tax bills to your mortgage company, I suggest you check to make sure they are paid. Most mortgage companies do not pay Interim tax bills and you are not aware that they are unpaid until I send out Late Notices in November. Along those same lines, any tax bills that are not paid as of October 31st, are sent a Final Notice by me. This will be the last time you will be notified of unpaid taxes before being turned over to Tax Claim on January 1, 2016 for collection.

If paying by check, please review your check for accuracy. If it is incorrect, I will have to send it back. This is especially critical at the end of a payment period. If you use the mailbox to the right of the office door on August 31st and your check is incorrect, it will be sent back and then due at the Face period. I cannot accept payment for any amount other than what the current payment period is in. Likewise, with the changes in our mail delivery and sorting, postmark MUST be August 31st for School to be accepted. Please keep this in mind with the "slower" mailing delivery.
