As we look forward to the Thanksgiving and Christmas

holidays, remember the patrons of the food pantry. All food boxes are filled through the generosity of individuals. Government subsidies are not provided for holiday distribution. Donations can be left with the church office weekday mornings or Sunday during worship. As I sat down to write this article, I realized that it has been exactly thirty years since my husband, Barry, and I moved to Summit Township. Boy has this community changed during that thirty years! In 1985, when we drove up Peach Street, there was a Busy Beaver home improvement store, Howard Johnsons, Muggs Restaurant and then, darkness. Except for a few gas stations, nothing else on Peach Street existed and it was so dark at the intersection of Robison Road and Peach at night that I was afraid I would miss the turn to go to our new home. I thought we were moving from the City of Erie to "the country."

Once Summit Towne Centre developed and Peach Street Square was started, the Summit Township we know today was off and running. When I first became an employee of Summit (ten years after moving here, in 1995) the Kohl's store held its grand opening. This was the first ribbon cutting I attended for a Summit Township business. Barry really regrets that moment because I started shopping at Kohl's that day and have shopped there obsessively ever since!

I've really enjoyed having a front row seat as our Township continually develops, welcoming each new business to our community and celebrating with them at each of their grand openings. Another big part of my front row seat has been working with residential developers as they created the neighborhoods our new residents have moved into.

Hello all, well we are almost through another year. Things went fairly well, other than an extended cold winter and wet spring. I know people began to become very upset with deep packed snow banks and our plows continuing to dump fresh snow in the end of their driveways, myself included. I have lived in this area my entire life and I know it is something we must deal with. Drive one hour south of Erie County and winter conditions don't even compare to ours. I bring this up because winter is coming soon, so it is time to get prepared. The crew has our equipment ready to go and anti-skid and salt are stockpiled. They have recently done much crack sealing which helps preserve the roads and keep them from freezing, heaving, and falling apart. I was in Cleveland a few weeks ago and was surprised to see how rough their city streets are. Apparently, road maintenance has a tight budget there or it's just hard for them to keep



hard work is greatly appreciated. Also, hopefully, we will be doing more with our trails at Picnicana. We are planning to get a couple walking bridges installed over the creek. Being a municipality, it becomes difficult because we must consider the safety of everyone who might use the trails. There are rules for construction around water ways and other safety concerns, like weight limits and hand railings for fall protection. We have some ideas to use pre-manufactured bridges, like boat and marina docks, where we could just put them in place. Also on the trails, I am hoping to have more volunteer work parties with the FLB School District to help pile up all the branches from wind storms and stack them along the trails for us to chip and cover the trails. Another option is to take our large chipper back to the trails with a big tractor (when it is dry out) so we could thin some overgrown areas and chip the trees we cut for forest management. These trails are supposed to be somewhat natural, so paving them is out of the question because of the terrain and the fact that it would detract from the natural forest.

Our Township continues to expand with development, so please be patient when driving and put the cell phones away when driving! With more businesses continuing to be built, it only brings more traffic to our roads adjacent to I-90. Our exits have been developing for many years now and you cannot stop the progress. We do not have the right to stop a business from building if they follow the zoning rules and we do not have the right to tell them we do not want any more development if they own the land and follow the zoning rules.

Enough said for now, I hope everyone enjoys Thanksgiving with friends and relatives. Also, have a very Merry Christmas. If you have time or get bored, please consider helping out your favorite charity, either by donating time or gifts. Many less fortunate people could use a hand or a smile. • No parking on public roadways NOVEMBER 15th through MARCH 15th.

If your vehicle is on the road it CANNOT be properly plowed, creating a hazard for you, your neighbors and every motorist using the road.

#### No plowing snow across a roadway.

When you do this it leaves a trail of snow across the roadway, often substantial amounts, creating a hazardous condition for everyone traveling the road. If an unsuspecting motorist hits this snow they could lose control and you would be liable. This is also a PA Law, with fines up to \$300.

#### Put your headlights on.

PA Law mandates that vehicle lights must be on every time wipers are on due to inclement weather. This includes snow! Your headlights also help our plow operators see your vehicle better.

 Only mailboxes that are properly installed will be paid for (up to maximum \$50) if they are hit by a Summit Township Plow.
If your mailbox is hit and damaged by a Township plow and it does not meet our installation specifications, Summit Township WILL NOT pay for it! See page 9 for our mailbox installation requirements to make sure you comply. If your mailbox is not sturdy enough to withstand the snow hitting it and it falls over, YOU must repair it.
We will only pay for boxes that are hit by the snowplow itself (not flying snow).

#### <u>All property owners must shovel their sidewalks.</u>

Any accumulation in excess of two (2) inches must be removed from public sidewalks within 24 hours after the precipitation ceases.

Contrary to popular belief, our plow drivers do not, intentionally, put more snow in your driveway than your neighbor's! It's all about location, location, location. Any snow that builds up on the plow blade is, naturally, deposited at the first opening. If you are that first driveway after the plow turns a corner, you are going to get a LOT more snow. We also don't plow the end of your driveway in on purpose. Again, the snow WILL go into the first available opening, no matter what we do. If you don't want your driveway plowed in, you can clear an area at least 15 feet wide and a couple of feet deep to the right side of your driveway (as you face it from the road). This will allow a plow blade full of snow to be deposited BEFORE it reaches your driveway.

"KNOW BEFORE YOU GO": To help make decisions whether or not to travel during winter weather, motorists are encouraged to check conditions on more than 40,000 roadway miles (including color-coded winter conditions, info on traffic delays, and speed limit reductions) by visiting www.511PA.com. 511PA is also available through a smartphone application or by calling 5-1-1.

#### PERRY HI-WAY REMINDS YOU TO MAKE SURE TO MARK YOUR HOUSE

Please make sure your home is marked with your house number. We have had a few emergency calls lately where we passed homes or had a difficult time finding homes due to a lack of house numbers or house numbers that were too small or not easily visible from the road. We suggest a minimum of 4 inch letters on the house or mail box. For homes that sit back off the roadway you may want to put a post out front near your driveway with your number on it. A reflective letter is even better. Be sure your number is not covered by trees or bushes or other decorations. When marking your mailbox we ask you to place your house number on both sides of the box as we may come the opposite way from your mailman. Please help us to help you.

## Winter Safety, from your Summit Township Emergency Management Team

Yes old man winter will be here soon and who knows what he will bring. Let's take a quick look at a few things that can help prepare us for when winter hits us hard.

**Automobile safety:** Look at your tires; are they in good condition and have decent tread? Studded tires are a bonus for traction on ice and hard packed snow. Do a "Circle of Safety" around your car while cleaning snow off all windows, headlights & tail lights. Walking around your car will help make you aware of what is near your car or if someone put something next to your car while you were away. Tip: if you do get stuck you can use your floor mats under the spinning tire for traction.

Have an emergency kit in the car. Some kits have all you need, but if you want to build your own be sure to have jumper cables, small shovel, blanket or extra clothes, water and food in the event you become stuck or stranded. You could also search on the internet for the "The Kool Kit" or search for winter car kits.

**Home Safety:** Again have a minimum of 3 days' worth of food, water and necessities on hand in the event of a power outage or a storm that keeps you house bound. Have a bag of ice melt or salt for stairs and walk ways to help save from slips and falls. If you shovel your drive or walkways take your time and take breaks do not over exert yourself, many heart attacks happen while shoveling.

It's hard to believe that we are once again at the end of another year. Where does the time go?

As of November 1, 2015, all taxes are now in the 10% Penalty pay period. Final Notices were sent to those property owners who have unpaid tax bills. Please carefully read the insert with your unpaid tax bill. All information you may need is provided for you in this insert.

#### **Please Note:**

- 1.) Office hours beginning November 1, 2015 until March 1, 2016 are by appointment only.
- 2.) The office will be open Thursday, December 31st from 9AM to Noon for cash payments. Please have exact change.
- Payments beginning December 15th MUST be in certified funds Cash, cashier's check or money order. This is stated on your tax bill and will be strictly enforced. Payments that are not in certified funds beginning December 15th will be returned.
- 4.) Payments must be in my possession on December 31st. Postmark WILL NOT be accepted.
- 5.) You may use the locked mailbox to the right of the office door marked "tax payments" at any time. I check this mailbox 7 days a week.

#### SUMMIT TOWNSHIP INCREASES LOCAL SERVICES TAX (LST) FOR 2016

At the November 16, 2015 Board of Supervisors meeting, a public hearing took place regarding raising the LST tax (formerly known as the Occupational Privilege Tax) from \$10 per person employed in Summit Township each year to \$52 per year (the maximum allowed by law), beginning in 2016. Following the public hearing, the Board voted unanimously to approve the increase via Ordinance #2015-05.

The current \$10 tax is divided between the Fort LeBoeuf School District and Summit Township, with each receiving \$5. Out of the new \$52 tax, Fort LeBoeuf School District will receive the same \$5 amount and Summit Township would receive the remaining \$47. The Ordinance states that the \$42 increase in tax to Summit Township may be used solely for the purposes of emergency services, which shall include emergency medical services, police services and/or fire services. The Township must use a minimum of 25% of this tax for emergency services.

The LST increase was not taken lightly by the Board. However, in light of the increasing burden to Perry Hi-Way Hose Company (PHHC) due to our growth and expansion, coupled with a decreasing number of volunteers to handle this burden; it has become evident that additional funding will be required in order for Summit Township to continue to meet our public safety needs. Increasing the LST tax puts the burden on those employed in Summit Township, many of whom are using the services of PHHC. Any person employed in Summit Township who makes less than \$12,000 will be exempt from paying the LST tax.

Summit Township has now joined the following municipalities that already charge a \$52 LST: City of Erie, Elk Creek, Fairview, Harborcreek, Millcreek and Washington Township.



Once you register on the site, you can view your bill, make a single payment, or schedule auto-payments. Convenience fees apply when you pay electronically: \$1.00 for e-checks; 2.75% (+50c if your bill is under \$100) for credit/debit cards. We will continue to accept cash or check payments at the Sewer Authority office, in person, by mail & in the drop box at 8890 Old French Road. We hope the new variety of payment options provides more flexibility for our customers.

#### **Route 97 Lift Station Project**

Construction on the replacement of Holiday Inn Pump Station is underway. The new pump station is being built behind the Taco Bell on Route 97 just south of the I-90 Interchange. The project is expected to take one year to complete. This station will likely serve the eastern portion of Summit Township now and for the next 75 years. ## **MAILBOX REQUIREMENTS**

### HOUSE NUMBERS MUST BE AFFIXED OR PAINTED ON BOX IN NUMERALS NOT LESS THAN ONE INCH, AND PLACED ON BOTH SIDES OF BOX.


#### IF A STORM WATER DITCH FRONTS YOUR PROPERTY:

- The post or pipe must be set in back of the ditch.
- The arm must extend over the ditch so that the face of the mailbox is between the front edge of the ditch and the edge of the pavement.
- Height (from the bottom of the box support) should measure 48" 52" from the road surface.
- The paper box should be attached to arm or mailbox to avoid snowplow damage.
- Summit Township will not repair any mailboxes that are not built to these specifications.

#### IF <u>NO</u> DITCH EXISTS IN FRONT OF YOUR PROPERTY:

- The face of the mailbox should be a minimum of MAILBOX 14' from the middle of the road.
- Height (from the bottom of the box support) should measure 48" 52" from the ground surface.
- The face of the mailbox must not extend beyond the face of the curb.
