TRAFFIC IMPROVEMENTS SCHEDULED FOR EDINBORO ROAD

Route 99 (Edinboro Road) is scheduled to be restricted to one-lane traffic during daylight work hours beginning April 24th and continuing for approximately one month approximately 700 feet north of the intersection with Hershey Road in Summit Township. The restriction is to allow a contractor to widen the road to accommodate a turn lane for private development.

KNOW HOW AND WHEN TO BURN BEFORE YOU START A FIRE!




The only items allowed to be burned are tree limbs, brush, leaves and other NATURAL vegetative matter. All other items (papers, newspapers, magazines, cardboard) must be recycled and cannot (by state law) be burned. Everything else that can't be recycled is trash and must be disposed of properly. This includes lumber and all other types of home or demolition waste.

If you are burning natural vegetation in a barrel or container, no permit is needed. If you are burning out in the open, a PERMIT MUST BE OBTAINED FROM SUMMIT TOWNSHIP PRIOR TO BURNING! There is no fee for this permit and we keep permits on file for easy renewal via phone. Call the Township at 868-9686 for more information.

SELF-APPLY FOR REVERSE 911 TO GET EMERGENCY NOTIFICATIONS

Would you like to receive information directly from the 911 center when there's an issue near YOUR home? The main reason to apply for reverse 911 is to be informed. If there is an issue near you, a message will be sent to advise you of the situation and tell you what to do in response to the incident.

All you need to do is go to the Erie County website to register:

- 1. Go to www.eriecountypa.gov and click on "County Services" at the top of the page
- 2. Click on "Safety & Law"
- 3. Click on "Public Safety"
- 4. In blue box click on "NWPAERG Regional Emergency Notification System Self-Registration Portal"
- 5. Check box to agree to the terms and conditions of registration.
- 6. Fill out information to register, set-up account and password.
- 7. An email will be sent to the email address you provide you MUST click the link in the email to complete your registration. If you do not immediately get the email, check your junk mail folder.

No late registrations will be accepted.

Registration fee for the Day Program is \$150 per child. Immediate families with three or more children will be charged \$350. Pre-school registration fee is \$100 per child. Contact Pat McGuire (868-9032) if interested in a one-week registration at a cost of \$50/ week per child. Reguests will be honored, based upon availability, on a first-come first-served basis.

We have several exciting projects this year slated for Picnicana. The first is the construction of a 32" x 48" storage barn that will replace the dilapidated barn that sits at the northeast corner of the park. Construction will take place after Residents' Weekend and we will construct an access road along the north property line so that we do not interfere with the activities of the park. This facility will be used to house all of the summer program supplies.

The Community Park concession stand has been reroofed, resided and new steel doors have been installed. The concession stand will be open for business with the help of the Fort LeBoeuf Soccer Booster Club.

Hello Everyone,

Spring is here and it's time to cut the grass. It certainly doesn't take long once the air temperatures warm up. The plows have been removed from the trucks and the road crew has been out cleaning streets and preparing for road maintenance. Our parks are also being prepared for the season. Everything is going well at this time.

As Township Supervisors, we have had two additional challenges with the state and pleading our case to protect what we have. One is the thought of Governor Wolf charging each Township, that does not have a local police department, a \$25 fee per resident for the service of our State Police. This is one of the state's ideas to help balance the state budget because of a large deficit. Many of the Erie County Township Officials have written letters and met with Senator Dan Laughlin telling him that none of us approve of this idea. Senator Laughlin said he will hand deliver the letters to the Governor.

The second issue started last fall. To sum it up, the PA Supreme court decided the gaming law, that affects what funds the county and local municipalities receive, was unconstitutional. Some casinos on the east end of the state lobbied to challenge the current distribution of money, so, to correct this, our legislators in Harrisburg must pass a bill to fix the language and make the current share constitutional.

Summit Township and many others know that, while collecting the extra revenue, there are many other expenses that go along with being the host municipality, like the extra work load/stress on our volunteer fire department, traffic and traffic lights the township maintains 24/7, and infrastructure for the water and sewer authorities to keep up with. I am not complaining, but just stating facts. I support our businesses and I lived next to the casino for 8 years. They are very quiet and keep a well maintained property. The Summit Township Supervisors recently attended a public hearing in Erie with the PA House of Representatives Gaming Committee. Supervisor Agostine testified before the Committee to plead Summit Township's case. She did a fine job of explaining all the details. On both issues, I feel we will be ok and things will stay the same as they are now.

I just bring these things up, because some people, and especially neighboring communities, sometimes think we have an unlimited bank account, but they don't stop to think, these operations do cause many additional expenses for a township. With that being said, I feel we, as supervisors, have a strong fiduciary obligation to protect our residents from additional costs of business in our township. There has to be a good and fair balance to do the best for all. Also, there is nothing wrong with banking some extra funds for that rainy day. We have an opportunity to stay financially sound and not end up with an unbalanced budget, like many governments and school districts are experiencing today.

Well, stay positive, enjoy the spring, but please do not text while driving!

SPRING CLEAN-UP 2017

FOR SUMMIT TOWNSHIP RESIDENTS ONLY!

Spring clean up will be handled as a **DROP-OFF PROGRAM** again this year. Township crews will only pick-up appliances containing freon (i.e. refrigerators, freezers, air conditioners and dehumidifiers) for residents who have registered and paid for the freon removal in advance (**No later than May 10th**). Residents may bring all other eligible items to the Township garage during the time period detailed below. Township personnel will be on hand to accept items, which must be generated solely from your household and not brought in from elsewhere.

All residents will be required to show proof of residency (photo driver's license).

GENERAL INFORMATION

Please read this information carefully! Only those items listed will be accepted, all others will be turned away.

ALLOWABLE ITEMS FOR THIS YEAR'S COLLECTION

- Air Conditioners (required freon removal fee paid**)
- Appliances Limited to two appliances per household.
 Duplicates of same appliance not accepted (i.e. two dryers).
 Refrigerators/Freezers (doors removed and required Freon removal fee paid**)

Dehumidifiers (required Freon removal fee paid**)
Washers (clothes and dish), Dryers, Stoves, Hot Water Tanks

- Auto Parts (NO GAS TANKS)
- Demolition Waste bathtubs, sinks, toilets, house doors and windows ONLY (no other building demolition waste such as shingles, wood or blocks will be accepted)
- Electronics TVs, computers, keyboards, monitors, etc.
- Furniture TV's, mattresses, mattress springs, couch, chairs, dressers, tables
- Lawn Mowers/Roto-tillers/Snowblowers
- Metal Items (unlimited)
- Tires (@ nominal fee see cost breakdown listed below **)
 Limit 12 tires per person.

ITEMS **NOT** ALLOWED – THE FOLLOWING ITEMS WILL NOT BE ACCEPTED:

- · No Bagged Material OF ANY KIND
- No Batteries
- No Demolition Waste other than items specifically listed above
- No Gasoline or Propane Tanks
- No Hazardous Waste OF ANY KIND
- No Household Garbage
- No Paint or Oil Cans
- No Junk Vehicles

If you are unsure about a specific item, please call the Township at 868-9686.

*** FREON REMOVAL FEE @ \$10.00 each (Non-Refundable) – Appliances that use freon require this fee payment to defray the cost of having Freon removed. Payment must be made at the Township Building by WEDNESDAY, MAY 10th. Crews will only pick up items with freon if the resident's name/address appears on a pre-paid list. Freon items must be placed CURBSIDE BY 8 a.m., THURSDAY, MAY 11th and will be picked up either the 11th or 12th.

** TIRE FEE – Tires will be accepted during drop-off hours with payment of the nominal per tire fee as follows:

\$2 – Tire OFF Rim \$3 – Tire ON Rim \$5 – Truck Tire (18 inch diameter or less) (19 inch diameter or more)

The nominal fee will help defray costs (per ton) associated with recycling of the tires by Waste Management.

(Note: Fee for tires is to be paid at the drop-off site, not in advance)

VEHICLES

Summit Township **CANNOT** take vehicles as part of spring clean up!

Vehicles that are unregistered/uninspected and visible on your property are in violation of Township Ordinances. Avoid prosecution by having them removed.

SUBMISSION DETAILS: No entry fee; Summit Township residents only; up to (3) entries per artist; must be no more than 30" wide (due to space); art must be framed or wired for hanging if you are a pastime or professional artist; student art needs only to be matted; entries can be marked "FS" (for sale) if so desired (an artist's inquiry box will be provided - all sales and any taxes are the responsibility of the artist.)

CURB WATER POLLUTION BY STARTING IN YOUR OWN BACKYARD!

A "stormwater-friendly" lawn is one that can absorb rainwater and does not harm local streams. Likewise, a "stormwater-friendly" garden is one that uses organic compost to amend soil and minimizes or eliminates the use of chemicals. Once established, they will help you save money on time, upkeep and fertilizers.

For a stormwater-friendly lawn:

- **Set mower height to 3 inches or higher** taller grass slows the rate of runoff and produces a deeper, denser root system which retains water and suppresses weeds.
- Retain grass clippings and chopped leaves onsite a mulch-mower is ideal for retaining and spreading clippings on your lawn. They quickly decompose, encourage water infiltration, and provide important nutrients reducing the need for nitrogen fertilizers.
- Keep clippings and leaves out of streams, off the street and out of storm drains if you can't mulch, bag clippings for a compost pile. If they get to water sources they become major pollutants detrimental to fish and aquatic life.
- **Do you need fertilizers for your lawn?** If so, use as sparingly as possible! Learn how much and when to use them properly.

For a stormwater-friendly garden:

- Use organic alternatives to chemicals and include manure or compost created in your own backyard apply before planting to avoid runoff.
- Before using pesticides, identify the pest and research your options many insects are harmless to plants and people, helping maintain a healthy ecosystem. If there is a problem, identify the exact pest and consult an expert (there are many nonchemical alternatives).

PERRY HI-WAY HOSE COMPANY NEWS...

AMBULANCE MEMBERSHIPS

We have had several recent inquires as to ambulance memberships and how they work. I will try to help you understand how ambulance membership works. The best news is that by living in Summit Township, you are automatically "members" of the Perry Hi-Way Hose Company Ambulance service. The Summit Supervisors and Perry Hi-Way have had this agreement since 1991 when the supervisors provided \$100,000 for the purchase of 2 new ambulances. That action has saved residents that amount 10 times over in the past 26 years.

Perry Hi-Way Hose Company is the primary provider of emergency paramedic ambulance service in all areas of Summit Township. Emergency ambulance service is for times when 911 is called for a sudden illness or injury and emergency medical care and transport to the local ER is necessary. Perry Hi-Way does not do routine transports for chronic medical conditions such as dialysis or physical therapy. We also do not do any wheel chair transportation such doctor appointments, or transportation to the hospital, surgery center or clinics for procedures. These non-emergency transportation needs are handled by Millcreek Paramedics or Emergycare for the Summit Area.

Currently Emergycare ambulance service solicits for membership in Summit Township. You can also purchase a membership with Millcreek Paramedics (MPS) if you choose. There are several benefits to purchasing an ambulance membership with one or both of these companies. It is a good and inexpensive "insurance policy" to help cover your co-pay, deductible or any expenses not covered by Medicare/ Medicaid or commercial insurance. It will also provide some coverage for non-emergency transportation needs should this be something you need. If you have an emergency outside Summit Township you will most likely

be served by Millcreek Paramedics if in Millcreek and Emergycare in the City of Erie. Your Perry Hi-Way "membership" will not cover you in those situations.

There are times when The Perry Hi-Way Crew is unable to respond due to multiple emergency calls at the same time and our 2 ambulances are already in use or all personnel are working at a large incident such as a fire or motor vehicle accident and not able to respond. In these instances we use Millcreek Paramedics for back up as well as Emergycare. Should you be transported by either of these companies your "membership" to Perry Hi-Way will not cover you or your family member.

You may ask: What is the benefit of spending the \$50 for a family membership to an ambulance service? The biggest advantage in purchasing the ambulance membership is to cover expenses not covered by your insurance including co-pay and deductibles. The average bill for emergency ambulance transport with paramedic is \$1400.00. Medicare will pay approximately \$390.00 of the bill. If you have not met your co-pay or deductible, they pay less. Many commercial insurance providers pay similar amounts. With a membership the unpaid balance is written off, without a membership you will be responsible to pay for the unpaid balance. You can see that the \$50.00 membership fee is a good investment.

The recommendation from Perry Hi-Way is to purchase a membership from both MPS and Emergycare if you can fit it in your budget. By having both memberships as well as being a Summit resident you will be well covered to avoid large out of pocket expenses should you need an ambulance in Erie County.

SERVICE INTERRUPTION

The Summit Township Water Authority makes every effort to provide its customers with continuous safe water; however, at any given time, pressure may be reduced or service interrupted to allow for emergency leak repairs. In emergency situations, it is impossible to notify our customers. We apologize for the inconvenience caused by unplanned service interruptions.

Under any other circumstances, including preventative maintenance and water main extensions, we make every effort to schedule these events at a time that will have the least impact on our customers.

It is important to remember that when water is restored following a service interruption, customers commonly experience cloudy or discolored water which can be cleared up by running the taps in your house until the water clears up. Typically the amount of water used to perform this task is nominal and under normal circumstances should not impact your bill.



FROM YOUR SUMMIT TAX COLLECTOR:

The 2017 County-Township (CT) bills were mailed February 28th and you should have received your bill by now. The color for this year is canary (yellow). County mills increased from 5.14 in 2016 to 5.41 in 2017. If you did not receive your tax bill, please contact my office asap. I have had many returns this year from the USPS. A great deal of these are ones that have not changed ownership or address and are being returned as undeliverable. I have contacted the Postal Service but have not received an answer that is acceptable except them saying it could be a sub. Therefore, if you are having any delivery problems, please remember you can put your payment (with SASE if receipt is desired) in the locked mailbox to the right of the office door at any time to ensure your payment is received in time.

We are now back to normal business hours of Monday-Thursday, 10AM to 2PM and Monday evenings 5-7PM. Additionally, you may now contact me via email at dacameron@roadrunner.com. If you email me between normal office hours of 10AM to 2PM you will receive a response that day. If outside business hours, email will be answered the next business day.

School tax bills for the 2017/2018 school year which begins July 1, 2017 and ends June 30, 2018 will be mailed on or about July 1st. I will not know if there will be a tax increase until the school passes their budget in June.

Berkheimer mails and collects the school per capita bills. The Fort LeBoeuf School District maintains the per capita list that is provided to Berkheimer. MS4 Storm Sewer Mapping Update

Summit Township is a designated Municipal Separate Storm Sewer System (MS4) community by the Pennsylvania Department of Environmental Protection (PADEP). As a part of the requirements of the PADEP's MS4 program, the Township is required to map the stormwater conveyance systems within the urbanized areas of the Township. This includes storm sewers, roadside ditches, swales, and detention facilities.

The mapping began last fall and will continue over the next year. As some of the stormwater facilities are located on private property, Township personnel will need to enter onto these properties to map the stormwater facilities. We ask for everyone's cooperation and assistance in completing the mapping process.

The Township is going to use the data collected through this mapping project to assess the overall condition and functionality of the current system. The mapping will serve as a great asset to the community and be a tool to assist the Township in future stormwater infrastructure improvements. Using the data collected during the mapping project, the Township will be able to identify and prioritize areas of the system in need of improvement. In addition, the Township will be able utilize the data to better address issues that may arise within the storm sewer system.

IS IT TIME TO RETIRE YOUR UNSERVICEABLE OLD GLORY?

'Retire Your Unserviceable Old Glory', will gladly accept your weathered, torn, faded or tattered flags for retirement. The 'Retire Your Unserviceable Old Glory' project is dedicated to collecting unserviceable flags for proper retirement.

You may visit the Summit Township Municipal Building, 1230 Townhall Road W., Erie, PA 16509 during regular business hours to deposit your flag in the 'Retire Your Unserviceable Old Glory' bin and it'll be properly retired.

ANOTHER TAX SEASON COMES TO AN END!

With the close of Tax Season your Volunteer IRS/AARP Tax Law Specialists Wanda Watkins & Trish Catalano would like to thank our Summit Township Supervisors, Employees and all of you that made this an exciting and busy tax season. We loved every minute especially catching up with previous clients and meeting so many new clients that we hope will return next year.

Your word of mouth and the Summit Newsletter ad was instrumental in allowing us to break our previous return record. In past years we processed under 200 tax returns, this year we E-Filed over 300 returns, over a dozen on paper and assisted with dozens of amendments to help solve previous years tax issues. You kept us busy up till the April 18th deadline, where in previous years we shut down a week early...Thank you. Please keep spreading the word to help others save money and headaches on their tax returns. Remember there is no age limit and everyone of any age is welcome, you don't have to be elderly or a AARP member nor a Summit resident to use our service and yes, we do assist with complicated and itemized returns (but some restrictions do apply). We're proud this year to have helped everyone from a 14 yr old paperboy who was excited to file his 1st tax return to our special client celebrating her 102nd birthday. Please keep sharing with your family, friends, and neighbors to make next year even greater.

If you're Disabled (any age), a senior (over 65) or Widow (over 50) and own a home/mobile home or rent, you may be eligible for up to a \$650 rebate from the PA Property Tax & Rent Rebate, if as a renter you make under \$15,000 or homeowner under \$35,000 (counting only $\frac{1}{2}$ half of your social security amount). Deadline to file is June 30th, 2017 but it may be extended and assistance is still available to file your return.

PA Retired Senior & Disabled residents earning under \$19,200 yearly are eligible for the Penndot MV-371 Vehicle Registration Discount which reduces your registration cost from \$36 to only \$10 yearly. Contact Penndot or a notary for more info.
