RT 99/HERSHEY ROAD WATERLINE RELOCATION PROJECT UPDATE

Manager Troutman updated the Board on the RT 99/Hershey Road Waterline Relocation Project by informing that all the piping has been installed and pressure tested. The water quality test came back good and is now ready to be put into operation. Troutman expects the interconnect valves to be opened and water re-routed into the new line early next week. If all goes well, work will start on abandoning the old pipe immediately after.

Troutman said he is still working on a resolution to improve our automated system communications. Velocity Network has indicated a willingness to work with the Authority by possibly installing fiber optic lines and other options are still being explored.
