Just a couple quick thoughts as we head towards the start of a new school year. As the buses will return to the streets transporting our young adults and children to and from school, please be mindful that the buses may be making frequent stops. Remember, when the yellow lights are flashing, proceed with caution and be prepared to stop. Absolutely no passing buses with lights flashing.

Also, the state has begun stepping up enforcement of boating regulations. The Fish and Boat Commission is issuing citations to kayakers or canoers that do not have one personal floatation device per passenger. The number of deaths due to accidental drowning have been steadily increasing over the past several years. As of August of 2014, according to the commission, there had been 15 boating fatalities in 2014 so far and 17 occurred in 2013, exceeding the average of 13 deaths annually. You don't have to wear a life jacket as long as it is not a cold water month, but you must have one present with you. Be careful and be safe.

Hello all! I just saw on the evening news that June broke an all-time rainfall record in our area, and we have had the 4th driest July on record. I bring this up because we did receive several complaints of wet yards, ditches, and neighbors' water draining onto their property. This is something we cannot control. We do the best we can by trying to control it with experience and engineering. That is why storm water management is so important in a busy community with so many buildings, hard surface driveways, and parking lots. These busy areas produce a tremendous amount of water run-off during wet, rainy times, or storm events. Without storm water management and using retention ponds, properties, creeks, and roadways would be destroyed. I have seen videos of old school developments where storm water management was ignored. Many people do not realize how excavating, ditches, and dams on their own property can affect others, so this is why you should ask for help or direction from the township; it's a big part of land development planning.

Recently we held our Residents Weekend at Picnicana Park. Many people participated and everything went very well. We had perfect weather all weekend, much food, bingo, a movie, a bounce house, and a blow up slide. Last year's parking expansion has worked out well too because it looks like this is keeping cars from parking on the road when the park attracts large crowds.

Road repairs, sealcoat or tar and chip are continuing. I feel that over the years, Summit has been doing a very nice job keeping up with our roads. My personal opinion is

that we have the best-kept roads in Northwestern PA. One problem with that may be people tend to drive faster than the speed limit when roads are well-maintained, so please drive with caution and watch the speed limits. We do have a busy township so our roads can become busy.

I don't want to wish winter here too soon, but this is a good time to make sure your mailbox is built per our specifications to help the plow trucks do their job without damaging the mailbox. If you live on a township road, we will repair a mailbox we damage if it was properly installed. A copy of the mailbox requirements is included in this Newsletter (see page 10). This does not mean replacing an old mailbox in poor condition. That is more than fair. Other municipalities and PA Dot will not repair or replace damaged mailboxes.

One more thing - Our parks do belong to all of us, the same as your personal property, so please help us police the properties from vandals. We recently have had some vandalism and this is senseless. I do not understand what someone gets out of this. We do have many good people watching and video surveillance. So, I for one would not hesitate to file charges with the law if you are caught. Enjoy the rest of the summer and fall. If you have any positive ideas or feedback, please come to a township meeting and share them. Summit posts all meeting dates and functions on your annual recycling calendar.

Eagle Scouts Improve Picnicana Trails

Peter Caulfield, Eagle Scout of Boy Scouts of America Troop 96, designed and erected seven informational signs along the inner trail of Picnicana Park August of last summer. He worked with Supervisor Jack Lee on this project. While walking along this trail one can learn to identify trees and interesting facts about common trees in northeastern forests, as well as the wild lilies of the valley.

Timothy Caulfield, his older brother, also an Eagle Scout in Troop 96, worked with Supervisor Jack Lee and Zoning officer Nathan Miller in mapping out the new trails at Picnicana Park. He fastened color coded trail blazes along the trails and placed signs with maps of the new trails at both trail heads. On the signs is an aerial image of the park with the trails superimposed. The trails are color coded and coordinated with the blazes, and the distances are marked for each.

Timothy Caulfield joined Boy Scouts when he was eleven years old. He became Senior Patrol Leader when he was thirteen, and held the position for three straight years. Last summer he was reelected Senior Patrol Leader and will lead the troop until he turns eighteen in April.

Timothy has attended summer camp at Custaloga Town Scout Reservation for the last six years. Last summer he participated in Council Adventure at the high adventure base in West Virginia, the Summit Bechtel Reserve. During his scouting career, Timothy earned thirty-three merit badges and was elected into the Order of the Arrow, scouting's national honor society.

Timothy is currently a senior in high school. He has been accepted to Gannon University and plans to begin his studies of Supply Chain Management there in the fall.

Peter Caulfield was born in Glenville, West Virginia, the seventh child of Dr. Michael Caulfield and Stephanie Caulfield. He and his family moved to Erie the summer of 2002, and soon after the move, the treasurer of Troop 96, Mr. John Walsh, invited the oldest Caulfield boy, Joseph, to join the troop. Peter's older brothers Joseph and Stephen Caulfield both went on to become Eagle Scouts, which made Peter eager to join Scouts when he turned eleven in 2012.

That summer Peter earned his first merit badge, Computers. Over the next four years he gained 28 more. A few of his favorites were Kayaking, Shotgun Shooting, and Cycling, for which he completed a 50-mile biking trip.

In the spring of 2016, he was elected into the national honor society of the BSA, the Order of the Arrow, and he completed his initiation Ordeal last August.

Peter is a junior in high school, and plans to attend Gannon University after his senior year, to study Mechanical Engineering.



PA 2-1-1 Fact Sheet

2-1-1 is the social services equivalent of 9-1-1.

- It is a comprehensive Information/Referral service available to everyone via:
 - An easy-to-remember phone number with texting capabilities
 - Online site with a searchable database of agencies/programs/resources
- The transition of home-grown information hotlines to 2-1-1 began in Atlanta in 1999.
- 2-1-1 now encompasses all 50 states and Canada.
- SW PA 2-1-1 in Pittsburgh has been operational for 3 years, serving the 11-county region.

Advantages:

- It's free, confidential and convenient.
 - SW PA 2-1-1 has found that callers were making 4 to 7 calls before being connected to the right resource/service.
- It's cost-effective.
 - One study in TX found that a national 2-1-1 system could generate a \$1.1 b net value to society over 10 years.
- It quickly connects people to safety net services.
 - SW PA 2-1-1 found that 70% of calls are for basic human needs: food, clothing, rent/mortgage/utility assistance.
- · It's professional.
 - · Call centers must meet stringent standards established by the Association of Information and Referral Specialists.
- It's proven its worth in times of disasters.
 - For a) people who need assistance and b) people volunteering their assistance.
- It uses innovative technology to maximize efficiencies.
 - In PA, 2-1-1 call centers use a common database which makes it possible to coordinate resources across county/regional lines.
 - PA is currently developing a smart phone app to streamline assessment process from 3 days to 30 minutes following a community disaster.

History of 2-1-1 in Pennsylvania


- PA was 2nd to last in nation in implementing its 2-1-1 network.
 - Today, NW PA is the only region not served by 2-1-1.
- Effort is being led by PA 2-1-1, a 501c3 nonprofit with significant (non-financial) support from United Way of Pennsylvania.
- Without a state-wide 2-1-1 network encompassing all 67 counties, PA 2-1-1 cannot compete for fee-for service contracts from the state.
 - PA, over the last few years, has established 450 special 1-800 information phone lines to provide information to the public on specific topics, issues, disasters, crises.
 - Approximate cost per 1-800 line is \$135,000.
 - With a state-wide 2-1-1 network, there is an opportunity to reduce costs to the state and generate revenue for the 2-1-1 network.

Status of 2-1-1 in Erie County and NW PA (February 2015)

- United Way of Allegheny County, which oversees SW PA 2-1-1, has agreed to add the 12 counties of NW PA to their 2-1-1 call center on an incremental basis.
 - Price tag for the region is \$300,000.
 - Erie County's "share" is approximately \$100,000 based on percent of total population.
- Consolidation of call centers in Pittsburgh:
 - Is more cost-effective than a separate call center for NW PA.
 - · Creates economies of scale.
 - Sends a positive message to potential funders.
- On February 25, 2015, the board of United Way of Erie County made a five-year commitment of \$70,000/year to 2-1-1.
 - This provides leverage in securing additional funds.
 - We will coordinate fundraising for the balance of Erie County's share of total cost.
 - We will assist the region in identifying potential funders which could include: local government, foundations and local United Ways as well as corporate sponsors.
- Information from the recently released Gannon University Human Service Directory will be used to populate the 2-1-1 database with agency/program/resource information.
- A launch date for Erie County has not yet been determined.
- United Way of Allegheny County plans to re-brand SW PA 2-1-1 as Western PA 2-1-1 at the appropriate time.







As of February 2015, 2-1-1 call centers are operational in five of the seven regions. The Central region has been absorbed by regions in the eastern part of PA; the NW region will consolidate with the SW region.



MAILBOX REQUIREMENTS

HOUSE NUMBERS MUST BE AFFIXED OR PAINTED ON BOX IN NUMERALS NOT LESS THAN ONE INCH, AND PLACED ON BOTH SIDES OF BOX.


IF A STORM WATER DITCH FRONTS YOUR PROPERTY:

- The post or pipe must be set in back of the ditch.
- The arm must extend over the ditch so that the face of the mailbox is between the front edge of the ditch and the edge of the pavement.
- Height (from the bottom of the box support) should measure 48" 52" from the road surface.
- The paper box should be attached to arm or mailbox to avoid snowplow damage.
- Summit Township will not repair any mailboxes that are not built to these specifications.

IF <u>NO</u> DITCH EXISTS IN FRONT OF YOUR PROPERTY:

- Height (from the bottom of the box support) should measure 48" - 52" from the ground surface.
- The face of the mailbox must not extend beyond the face of the curb.

The residential sewer rate will increase from \$81.00 per quarter to \$87.00 per quarter. For low flow commercial customers the rate increases from \$4.63/1,000 gallons to \$4.97/1,000 gallons. For high flow (>800 gallons per day) commercial customers the rate increases from \$5.25/1,000 gallons to \$5.64/1,000 gallons. The new rate is reflected in the September 2017 billing.

Management is recommending a rate increase for several reasons: the system has grown to the point where additional maintenance staffing is required; commercial and industrial usage (therefore revenue) is down; additional funds are needed to continue with necessary system upgrades and for future clean-up projects.

SYSTEM GROWTH

From 1996 to 2017 the STSA has seen a significant amount of growth:

The growth in the system has been in excess of 80% across all of the above categories. We simply need more staff to maintain the system.

LIFT STATION UPGRADES

The STSA is responsible first and foremost for the continued operation of the existing public sanitary sewer

system. Toward that goal the Authority must from time to time perform upgrades to the existing facilities to avoid backups and/or sewage discharges to the environment. Our current project is the upgrades to the Meadows Lift Station. This lift station was originally acquired from The Meadows Subdivision development in 2003. The lift station now serves South Hill Road, Cherry Street Extension and the Johnson Road areas. The larger service area means a larger load and now we are in need of more capacity. The capacity upgrades include: larger pumps, new larger electrical service and panels, backup power generation and controls. Engineers from Greenman-Pedersen, Inc., (formerly Hill Engineering) have started the design. Once the preliminary design is complete a detailed cost estimate will be developed. The STSA plans on bidding the work in the spring of 2018.

FUTURE CLEAN-UP PROJECTS

Another mission critical responsibility of the Authority is to extend the sanitary sewer system either by Pennsylvania Department of Environmental Protection (DEP) mandate or per the comprehensive sewer plan. Please know that the Authority is continually investigating projects and when the next project is official the affected residents will be notified at the appropriate time.

Lastly, please bear in mind the STSA is committed to providing each customer with quality service at the best rates possible. If any sewer customer has any questions or concerns, please feel free to call the Authority at 868-4495 or attend a monthly meeting. Check your Township calendar for Sewer Authority meeting dates. The Authority office hours are 8:00 AM - Noon and 12:30 - 4:30 PM, Monday through Friday. If you plan to attend a meeting, please call and let us know. We will be glad to put you on the agenda.



FROM YOUR SUMMIT TAX COLLECTOR:

Happy Summer to All!

By the time this newsletter reaches everyone, we will be approaching the end of summer and the beginning of fall. Time sure flies!

The 2017 County-Township bills are now in the 10% penalty phase as are Interims mailed 1-1-17, B16-2016. The 2017/2018 School bills are at 2% discount until August 31st as are Interims mailed 7-1-17, B16-2016 and A17-2017.

Please check with your mortgage company if your taxes are escrowed and you have sent them an Interim to pay. Not all escrow companies pay Interim tax bills and you do not find this out until I send Final Notices in November for those that are unpaid. You may also call me or email me at dacameron@roadrunner.com to see if those Interims were paid.

There has been a lot in the news lately about hacking. The tax program I use was specifically designed for Summit Township. It is on a dedicated server and no one has access to your records and payments except for me. Additionally, there is an off-site backup backed up everyday and I also keep a hard copy of all records also. I turn over all hard copy documentation to the taxing authority, Summit Township once I settle for the year. They are kept in a secure area in the Township building. The chances of your information being hacked or stolen is very unlikely.

All real estate tax bills have been sent for the year. The next regular tax cycle begins March 1st for the 2018 County/Township. Look in your first quarter newsletter for information regarding mills for 2018, mailing dates and any other important information.
