A convenience fee of 2.75% (+50¢ if payment is less than \$100) will be added to credit/debit card payments; a convenience fee of \$1.00 will be added to checking/ savings e-check payments. Seems the older I get, the faster time goes by. With that being said, please keep in mind it's time to think about plow season and snow removal. Please secure your mail boxes or get them up to par. Don't park along the sides of the streets or roads, especially during snow events, so the plow trucks can do their job and clear the roads. The large trucks do not maneuver easily and driving one is harder than it looks. They don't purposely fill driveways either. As frustrating as it can be sometimes, it's all part of living in Northwestern Pennsylvania. All of us deal with it.

We have heard some good news that the gaming money bill passed in the house, but waiting for the governor to sign it. Summit Township Community Attitudes Survey Results

Thank you to everyone who took the time to fill out the Summit Township Community Attitudes Survey! The survey will be used to inform the update to our community's Comprehensive Plan, which will set out future priorities for the Township and will be used as input for the day-to-day decisions of our local leaders. The objective of the survey was to collect information about the preferences, beliefs, and characteristics of our residents to ensure that the Comprehensive Plan reflects the desires of the community.

The Community Attitudes Survey was made available to all residents and property owners to complete throughout the month of October. It was sent to all residents and property owners by mail and was also available on Summit Township's official website. The questions covered a broad range of topics, such as reasons for living in Summit, concerns about the future, transportation issues, and satisfaction with the provision of utilities and other services. The survey also provided an opportunity for respondents to submit comments.

Through the month of October, 720 households (of the 3,600 households receiving them) responded to the survey. A 20% response rate is truly fantastic and helpful for informing planning ideas! Of the respondents, 94% are owners and 6% are renters, and 41% have lived in the Township for 20 or more years. According to the latest US Census' American Communities Survey data, owners make up about 87% of Summit's population, and 34% have lived in the Township for 15 or more years. This means that, on average, survey respondents have lived in the Township longer than the general population, and are more likely to own their property.

The pride that Summit Township residents feel for our community was evident in the survey responses. Many respondents used the comments section to praise the Township, especially the balance between rural character and convenient access to amenities. 90% of survey respondents said they were "satisfied" or "very satisfied" with the Township as a place to live or own property. When asked to select their top three favorite things about Summit, respondents rated rural landscape/open space highest, followed by access to highways and shopping/dining opportunities. When asked why they chose Summit, the most popular reason respondents gave was the rural setting, followed by low taxes and quality schools.

Respondents also voiced their concerns through the survey. When respondents were asked to list their top concerns about the future, increased traffic was the most common choice, followed by loss of open space, dense development, and commercial/population growth.

Among respondents, transportation issues such as traffic, speeding, and dangerous intersections were of primary concern. Currently, residents of Summit enjoy comparatively short commute times—77% of respondents said their commute takes 20 minutes or less. However, many respondents feel that traffic has increased. There is also a great deal of concern over excessive speeding on commercial/residential streets, enforcement of existing speed limits, and speed limits that are too high for residential streets with no sidewalks.

In the comments section, respondents took the time to provide detailed feedback on specific intersections and streets that require attention. Many respondents pointed out that the Five Points intersection at the entrance to the Erie County Technical School is especially in need of a redesign. Specific residential streets where speeding is a problem or speed limits are too high were also mentioned.

Respondents voiced support for improved bicycle and pedestrian amenities. 51% of respondents said they would bicycle or walk to parks if they believed it was safe to do so and many comments suggested sidewalk improvements to major streets. However, lack of pedestrian and bicycle



access to major destinations within the Township was a minor concern for most respondents compared to excessive traffic and speeding.

Respondents also voiced concern about the pace and nature of development. Population growth, traffic levels, as well as the prevalence and quality of open space are all related to this. When asked about the extension of utilities, there was an even split among those who do not have public sewer and water access—about half want service extended, while the other half does not. There is interest in increasing access to high-speed internet—88% of respondents who do not currently have access said they would like service extended to them.

When asked about their level of satisfaction with tax-funded municipal services, respondents were most satisfied with road maintenance and fire service/ EMS. This was also reflected in the comments section, where many residents praised the responsiveness of our community's road crews.

Finally, respondents voiced their support for the Township's newsletter, with 85% of respondents saying that it is their preferred way to receive information about Township-related activities, alters and events.

Thanks again to everyone who took the time to participate in the survey! Your responses and written comments will inform the goals and objectives of the Comprehensive Plan update - ensuring that the process represents and balances both the needs and the desires of our community.





Throughout the winter, the crews plow snow, apply salt and anti-skid to the Township roads to make winter travel safe for township residents and visitors. Summit township has six excellent snow removal trucks that can be used to clear the roads. Residents are required to help the crew's work by obeying the law and removing their cars from public streets from November 15th to March 15th. This allows the Road crew to do a nice job of cleaning the roads. If a vehicle is left parked in the road, we do have the right to tow it away at the owners expense, for everybody's safety. Summit Township has enough equipment to be able to keep up with the weather better than most anyone and, in our busy community, people have come to expect that.

Roads are a public right-of-way. Township standards are to clear the road from edge to edge or curb to curb to provide safetravel conditions and provide storage space for subsequent snowfalls.To do this sometimes requires multiple passes. We move the snow from the centerline to the edge of the road. This means that, until the street is completely clear, the plow will come back again. The plows are not lifted at driveways because this would leave snow on the street; creating a hazard for drivers. Residents should be advised to wait as long as possible to shovel or clear at the end of their driveway. Also, when removing your snow, deposit the snow to the right of your driveway as you face the street. By doing this, when the plow returns, it will carry the snow you moved away from the driveway. Snow placed on the left side will probably end up back in your driveway the next time the plow makes a pass. Not all of the streets or roads in the township are public. Some are private drives that are maintained by owners, homeowners associations, or developers. We also have many state roads in our Township which are maintained by PennDOT. We are not supposed to plow any part of the state roads, even if we think we are doing a favor. If we plowed a portion of a state road and then turned off onto one of our township roads, a motorist could be driving down the road on that plowed portion (thinking the road has just been plowed) then suddenly hit deep snow, causing them to have an accident where we turned off and did not finish.

Property owners and/or occupants are responsible for clearing snow and ice from adjacent sidewalks within 24 hours after the end of a snowfall. Owners or occupants failing to clear sidewalks may receive a citation, be fined and/or be responsible to reimburse the township for the cost of clearing the sidewalk. Please drive safely, slow down, and allow extra time to reach your destination during winter weather events. This is the most effective way to prevent an accident. Thank you for your cooperation and happy holidays!

IT'S TIME TO PREPARE YOUR HOME FOR WINTER!

When temperatures are consistently at or below 32°F the pipes in your home may be vulnerable to freezing. Here are some tips to prepare for the cold season.

- Eliminate sources of cold air near water lines by insulating walls, closing off crawl spaces, eliminating drafts near doors and repairing windows.
- Allow a small trickle of water to run overnight during extremely frigid conditions to keep pipes from freezing. The cost of the extra water is minimal compared to the cost to repair a broken pipe.
- Open cabinet doors to expose pipes to warmer room temperatures.

If your pipes freeze, shut off the water immediately. Apply heat to the frozen pipe by warming the air around it. Once the pipes have thawed, slowly turn the water back on and check for leaks.

PHONEBOOK RECYCLING FOR SECOND HARVEST

Bins are now in place to recycle your phonebooks and help raise money for the Second Harvest Food Bank. The drop-off bins are located at the Municipal Office (1230 Townhall Road West), Municipal Garage (8900 Old French Road) and Summit Senior Center (1450 Townhall Rd). **These bins will remain in place until January 30th.**

Prevent Water Pollution What is an Illicit Discharge?

An illicit discharge is the disposing, dumping, spilling, emitting, or other discharge of any substance other than rain water into the storm sewer drainage system. The storm sewer drainage system includes streets, ditches, catch basins, yard drains, and stormwater detention/retention facilities.

Unlike sanitary sewers, storm sewer drains **DO NOT** lead to treatment facilities. This results in illicit discharges causing water pollution by sending pollutants right into our swamps, streams, ponds, and lakes. Would you dump oil into Walnut Creek? If you dump oil into a drain at the end of your driveway then your answer would be yes. Be sure you know what illicit discharges are so you can help prevent water pollution and keep our water clean!

Examples of an illicit discharge include:

- Sanitary wastewater
- Effluent from septic tanks.
- Car wash wastewaters.
- Improper oil disposal.
- Radiator flushing disposal.
- Laundry wastewaters.
- Improper disposal of auto and household toxics.
- Sediment and pollutants from construction sites.

Any substance other that storm water discharged directly into the storm sewer drainage system is a violation of the Summit Township Stormwater Management Ordinance, the Pennsylvania Clean Stream Law and the Federal Clean Water Act. Violators could face possible fines and cleanup costs.

Please bring your 2016 tax return, all 2017 tax documents and your **STAMPED "PAID"** 2017 Property Tax Receipts if applying for Tax/ Rent Rebate. You will be rescheduled if you are missing Documents or ID at your appointment. All Clients must complete a new 4 page IRS Tax Intake Interview form upon arrival, so don't forget your reading glasses.

Replacement stamped "PAID" 2017 Property Tax Receipts can be obtained by calling the town Tax Collector one week or more prior to your appointment. PA Dept of Revenue restricts us from completing rebate forms without paid receipts.

FROM YOUR SUMMIT TAX COLLECTOR:

Greetings to All!

It's hard to believe that another year is winding down and the holiday season will be upon us very soon. Time sure flies!

All taxes for 2017 are now in the 10% penalty period. If your taxes were not paid by November 1st, you would have received a second "Final Notice" from me stating that your taxes were not paid. If you have any questions regarding unpaid taxes, please contact my office. If I am not in, please leave a message and I will return your call. The office is closed to foot traffic, but I still am working and you can make an appointment if a phone call will not suffice. You may also email me at dacameron@roadrunner.com.

The last day to pay your taxes with a personal check is December 15th. After December 15th, funds must be certified – Certified cashier's check, money order or cash are the only acceptable forms of payment. This is noted on the back of your "Final Notice" bill and on the insert with your bill. If you send your payment with a personal or business check, it will be returned and you run the risk of missing the December 31st deadline. TAXES MUST BE IN MY POSSESSION DECEMBER 31ST – POSTMARK IS NOT ACCEPTED AT END OF YEAR.

I will have a message on my answering machine stating which date at the end of December I will be open for cash payments.

Please check now to make sure you have stamped receipts for filing your PA1000 (property rent rebate) next year. If you do not have a stamped receipt, now is the time to contact me for next year.

IMPORTANT NOTE REGARDING SCHOOL PER CAPITA BILLS ISSUED THROUGH BERKHEIMER:

Per law, the only 2 exonerations for paying per capita tax are (1) under the age of 18 and (2) individual total income from all sources under \$10,000.00. There is NO EXONERATION for over the age of 65. If you qualify under either of these 2 circumstances, please contact FLB School District Administration at (814) 796-2638 for the appropriate forms to apply for the exoneration.
