After a nice summer, fall is upon us. With that, the parks have been cleaned up and closed for the season. Thanks to all who helped out putting things away preparing for the long winter ahead.

Speaking of winter, the trucks have been set up for plowing and salting our roads and parking lots to ensure safe travel throughout Summit Township.

We have stockpiled 900 tons of salt mixed with anti-skid in preparation for treating the roads to prevent ice build-up that can cause dangerous driving conditions. Our new salt storage building has made it possible to house this larger quantity of salt which should last the better part of an average Erie winter.

Hello all, another season has passed. As I write this letter, fall has been pretty mild so far and I hope it continues right through the winter. Remember to drive carefully when we do get that first snowfall to get used to winter road conditions. Check your tires for tread quality and tire pressures.

We did get many things accomplished at the township this year - cleaned out our stormwater pond behind the municipal building, cleaned up another field at Community Park, planted a long row of oak trees at Community Park that we received through a grant, took care of the annual road work such as signs, ditches, and painting line detail work, paving jobs, and one more sidewalk project completed.

The best project this year is the replacement of the Old French Road bridge just south of Townhall Road. There was no record of when the old bridge was built, and no stamped dates in the concrete. The edges were deteriorating and falling apart. This old bridge was very narrow with poor guide rails on it. The new bridge should be open before Halloween and before this newsletter is out. It is much wider with solid guide rails - a well overdue project completed.

We also added a small natural gas generator to our garage so if the electric goes out the road crew can easily turn the lights on and open the large overhead doors. If the electric does go out, this generator has its own breaker panel and switch that transfers over and automatically starts. That is very convenient at 4 a.m. when the plow crews come in. Otherwise you have to pull out a large step ladder to manually lift the overhead doors high enough to get the Mack plow trucks out of the garage.

We recently poured a 50' x 50' concrete pad beside the salt storage building. The whole road crew and I took on that project

which used 48 yards of concrete. This will be a good staging and mixing area for our salt and anti-skid which was always a gravel area. We also installed new fuel pumps with key fobs to record which vehicles and how much fuel was used. Then we poured a new concrete pad in front of the pumps, with a safety catch basin to retain fuel if there is a spill or accident.

Our Township has seen more growth this year. The U-Haul building on Downs Drive is still coming along and another developer has started to build a Holiday Inn on Downs Drive. This has been a great year as far as demolition. We helped encourage property owners to remove all the old abandoned buildings on Route 97 just south of I-90 and a few other places too. Those would have been considered to be blighted properties. This makes the land more appealing and look much better. I can only imagine what all the travelers who come off of I-90 used to think when they saw all those abandoned buildings there, but they won't see them anymore. Many people do not realize that it's fairly cheap to have old abandoned buildings demolished and removed especially one-story structures. There are no future land development plans at this time but it looks so much better.

Every year we chip away at something to keep upgrading our buildings and parks. We prioritize just like someone would do with their own homes. You take care of things that need to be fixed, renovated, or repaired now, and schedule other things further out in the future to keep a balanced sensible budget, and still maintain all your property, home, and buildings.

## PERRY HI-WAY RECEIVES GRANT FOR NEW "JAWS of LIFE"

Perry Hi-Way has been awarded a grant through the FEMA Firefighter assistance grant program to purchase new vehicle extrication tools, commonly called "The Jaws of Life". The new tools will be the next generation of tools by HURST that runs on Lithium-ion batteries and does not require a separate motor and hoses like our current system. The new tools are also designed to cut and spread the new high strength steels used in today's new vehicles to make the passenger compartments safer in the event of a crash. The new tools will be faster to put into operation and also be much quieter to use making the rescue scene less chaotic. The grant totaled \$61,000 and will allow us to purchase a new spreader, cutter, ram and combination tool (both cut & spread) for our rescue truck and a combination tool for each ambulance. The rescue truck will have the new battery system as well as the traditional hydraulic system.

The older tools removed to make room for the new battery tools have been donated to the Venango Volunteer Fire Department in Crawford County and the Union City Fire Department. The motor, cutters, and spreader donated to Venango will be the first set of "Jaws of Life" equipment their department has ever owned. The combination tool donated to Union City will add to their HURST Jaws of Life equipment as they have not had the combination tool before. We felt that donating this equipment to another department that could use it was the right thing to do since we were fortunate to receive federal funds for our new tools. Addressing the unique requirements of volunteer emergency services has challenged the Board of Supervisors who are not only responsible for the health, safety and welfare of Summit residents, but also for weighing costs to those same residents.

After months of discussions, research, and education regarding the status of volunteer fire companies across the United States, the Summit Township Board of Supervisors has negotiated a new funding agreement with Perry Hi-Way Hose Company (PHHC). While Summit Township has always attempted to generously provide funding to PHHC, this agreement will ensure funds to PHHC through June 30, 2022. The agreement outline is below:

2020-2021	\$848,920.00
2021-2022	\$866,708.00

Revenue generated from various sources including Presque Isle Downs, the Landfill, Employee Local Services Tax, and our commercial and retail developments will enable Summit Township to contribute this funding which will allow PHHC to continue operating and providing fire, ambulance, and rescue services for our citizens with full-time paid emergency responders along with volunteers.

# From The Office Of District Judge McGowan

## MDJ OFFICES, JUDGES AND STAFF

My staff and I have noticed an increasing number of people are coming into the office requesting advice on what to do. In some cases, they are advised by a township employee or a police officer or state trooper to “talk to the judge” or “go see the judge.” While my office can give some help in procedural matters such as advising of options for service, advising of filing fees and providing a state-approved form, we cannot give advice beyond that. My staff can never tell you what to write or what to say on the forms.

Court staff are not lawyers and cannot give legal advice. They are not permitted to give any help or advice about how to best handle your case because court employees, like judges, must remain neutral to protect the integrity and independence of our courts.

A judge is not an advocate for either side. I cannot give you legal advice about how to proceed or tell you what to do. This is in order to maintain neutrality for all cases. You can't see the judge just to “ask a quick question.” The court system is set up as an adversarial system where both sides present their evidence to the judge in the presence of each other. Therefore, each party knows and sees everything that the judge hears, sees and considers in order to decide the case. If a party discusses the facts of his or her case with me while the other party is not present, then the rules require that I recuse myself and your case will be transferred to another court.

If you need legal advice about what your rights are, what your options are and how to proceed to what to do next, you should contact an attorney. If you do not know how to contact an attorney that practices in the area you need assistance in, you can call Lawyer's Referral at 459-4411 and they will give you names of attorneys that could help you.

In case you are wondering what exactly it is we do in our office if we're not available to answer questions, Magisterial District Judges are entrusted with the authority to:

- conduct trials for criminal summary matters and traffic cases;
- conduct trials for civil claims where the amount does not exceed \$12,000, in the following types of cases:
  - landlord-tenant actions
  - assumpsit actions unless they involve a contract where the title to real estate may be in question
  - trespass actions
  - fines and penalties by any government agency;
  - preside over preliminary arraignments and preliminary hearings in criminal cases;
- set and accept bail;
- issue arrest warrants;
- accept guilty pleas to the charge of Driving Under the Influence so long as:
  - it is a first offense,
  - no personal injury occurred to a third party other than the defendant's immediate family,
  - property damage to any third party is less than \$500 and
  - the defendant is not a juvenile; and
- preside over non-jury trials involving all offenses under Title 34 (Game Commission Laws).

Many of the MDJs are active in the community that they serve. I have several programs that I participate in with students at the Fort LeBoeuf school district that I look forward to every year. They include participating in the sophomore panel discussion, a mock trial with Mrs. Dahn's 5th-grade gifted class and every fall I present a lesson to the third graders at Robison Elementary regarding the role judges play in our government.



# MAILBOX REQUIREMENTS

**HOUSE NUMBERS MUST BE AFFIXED OR PAINTED ON BOX IN NUMERALS NOT LESS THAN ONE INCH, AND PLACED ON BOTH SIDES OF BOX.**


## **IF A STORM WATER DITCH FRONTS YOUR PROPERTY:**

- The post or pipe must be set in back of the ditch.
- The arm must extend over the ditch so that the face of the mailbox is between the front edge of the ditch and the edge of the pavement.
- Height (from the bottom of the box support) should measure 48" – 52" from the road surface.
- The paper box should be attached to arm or mailbox to avoid snowplow damage.
- Summit Township will not repair any mailboxes that are not built to these specifications.

## **IF NO DITCH EXISTS IN FRONT OF YOUR PROPERTY:**

- The face of the mailbox should be a minimum of 14' from the middle of the road.
- Height (from the bottom of the box support) should measure 48" - 52" from the ground surface.
- The face of the mailbox must not extend beyond the face of the curb.

## **FROM YOUR SUMMIT TAX COLLECTOR:**

Well, once again another year is almost behind us! I hope everyone had a wonderful summer and fall.

By the time this newsletter reaches you, you would have received a Final Notice reminder if your taxes were not paid by November 1st. If your taxes are escrowed, please check with them first to see why they were not paid. Contact me with any questions either through email or phone listed below. **PLEASE NOTE THE FOLLOWING:**

- 1) *Payments after December 15th **MUST** be in certified funds-Cash, cashier's check or money order. Please put your phone number on checks and money orders. Non-certified payments will be returned.*
- 2) **Payments must be in my possession December 31, 2019. Postmark is not accepted.**
- 3) *Office hours Nov. 1 until March 1 are by appointment only as stated on your bill.*
- 4) *The office will be open Tuesday, December 31st noon to 2 pm for cash payments. Please have exact change.*
- 5) *You may use the locked mailbox to the right of the office door marked "Tax Payments" at any time up to and including December 31st. I check this mailbox daily.*

It is very helpful to have your phone number on your checks and if you are not sending a copy of your tax bill with the payment, please make sure either the address or parcel ID# is on your check or money order. Your parcel ID# is the number that starts with 40 (40 signifies Summit Twp) under the bar code. All information listed above can be found on your tax bill.

## ENGINEER'S REPORT

The Old French Road Bridge is complete and was opened to traffic on October 25, 2019. The construction started on September 18, 2019. Showman Excavating did a wonderful job and the weather cooperated for most of the project. There were a couple delays. We lost a week due to an underground utility conflict that resulted in the whole structure being shifted upstream two feet. The second delay was due to the weather and put the paving a week behind. That said, losing two weeks in delays and still being able to complete a bridge replacement project in 6 weeks is an impressive feat.

This was all possible by the use of pre-cast concrete components from Contech Engineered Solutions and accurate and precise construction practices. The foundations were pre-cast units with hollow cavities that were later filled with concrete. These were set in about 3 hours opposed to tradition cast-in-place foundations which would have taken weeks to construct. The bridge itself was 4 precast arches and 4 precast wingwalls that were set by a crane in less than a day.

The new bridge is a major improvement over the old bridge. The new bridge does not restrict the stream channel like the old bridge did. The new bridge has streambanks under the bridge which are a result of the additional span length. This should reduce scour of the bridge foundations, and downstream erosion. On top of improved stream flow under bridge, the new bridge is wider providing safety for the motoring public.



## SUMMIT TOWNSHIP EMERGENCY MANAGEMENT WINTER SAFETY

Old man winter will be here soon and who knows what he will bring. Let's take a quick look at a few things that can help prepare us for when winter hits us hard.

**Home Safety:** Have a minimum of 3 days' worth of food, water, and necessities on hand in the event of a power outage or a storm that keeps you housebound. Have a bag of ice melt or salt for icy stairs and walkways to help save from slips and falls. If you shovel your drive or walkways take your time, drink water, take breaks often, and stop if you feel out of breath, strained, or sore. Use a smaller shovel when the snow is wet. Also, have wood stoves or fireplaces inspected and cleaned.

**Auto Safety:** Install snow tires and have a snow brush/scrapper to keep windows clear for 360-degree vision. Be sure to clear off your headlights and taillights so others can see you. Leave a little early so you are not rushed. Have an extra blanket, winter coat, boots, and gloves in the car in case you become stranded.

**Driving Safety:** Keep a safe following distance. Only use cruise control on dry roads. Stay out of other vehicle's blind spots. Limit abrupt steering and braking.

## FROM THE SEWER AUTHORITY

### MEADOWS LIFT STATION

The Summit Township Sewer Authority (STSA) Board and staff are pleased to announce that our first pre-manufactured suction lift pump station was craned in place on October 25, 2019. Konzel Construction Company, Inc., Erie, submitted the low bid of \$582,000 back on January 24, 2019. Work was held up over 6 months while the station was assembled by Precision Systems in Calumet City, Illinois. The station weighs more than 26,000 pounds and features 3-30 horsepower Smith and Loveless Pumps and its own standby electrical generator.

Once the pump station was delivered it was up to Konzel Construction to place the station on the newly completed wet well. Work continues on the final electrical connections, piping, fencing, grounds and paving with the goal of turning the station on before November 30, 2019. The Meadows lift station is the first of its kind in Summit Township in terms of a pre-manufactured facility. We hope to see the station in service there for 50 years.



### COMING IN 2020 – OLIVER ROAD RELIEF

The STSA has found there is little capacity remaining in the public sanitary sewers serving Oliver Road. On September 10, 2019, the Authority's Engineer submitted preliminary information to the Pennsylvania Department of Environmental Protection (DEP) in accordance with the requirements of the Pennsylvania Sewage Facilities Act (Act 537). Each time a new development is proposed, the Municipality is required by state law to revise this official plan through a process referred to as a "Sewage Facilities Planning Module". This process also covers upgrades and extension proposed by the municipality or its authority.

The existing 8" and 12" diameter sanitary sewers need to be replaced due to capacity constraints. The original 8" was installed by a developer in 1990 and the 12" was installed in 1994. Since 1994 over 500 new homes have been built and another 100 are planned for already, and future development could result in another 400 new homes in the area.

The authority's engineer estimates the cost of the relief sewer at \$1,420,000. The project will include 3,320 feet of 12-inch gravity sanitary sewer and 2,100 feet of 15-inch gravity sewer. Two alternatives are going to be advertised for public bid. The first option is to remove and replace the pipe in its existing location. The second option is pipe bursting. Pipe bursting is a newer technique where-in a high-pressure hydraulic ram is inserted in the existing pipe. Once inserted into the pipe, the ram is pulled along the length of the pipe fracturing and displacing broken pieces into the surrounding soil. Simultaneously, a new carrier pipe consisting of a continuous high-density polyethylene pipe is pulled in the void behind the ram. Only the existing connections are dug from the surface of the ground to the new sewer main.

The STSA is planning on advertising the contract(s) and receiving bids for the work in the spring of 2020. If everything goes according to plan, the work will begin in the summer and conclude in the fall of next year.



## On the Roads Again!



Throughout the winter, the crews plow snow, apply salt and anti-skid to the Township roads to make winter travel safe for township residents and visitors. Summit township has six excellent snow removal trucks that can be used to clear the roads. Residents are required to help the crew's work by **obeying the law and removing their cars from public streets from November 15th to March 15th**. This allows the Road crew to do a nice job of cleaning the roads. If a vehicle is left parked in the road, we do have the right to tow it away at the owners expense, for everybody's safety. Summit Township has enough equipment to be able to keep up with the weather better than most anyone and, in our busy community, people have come to expect that.

Roads are a public right-of-way. Township standards are to clear the road from edge to edge or curb to curb to provide safe travel conditions and provide storage space for subsequent snowfalls. To do this sometimes requires multiple passes. We move the snow from the centerline to the edge of the road. This means that, until the street is completely clear, the plow will come back again. The plows are not lifted at driveways because this would leave snow on the street; creating a hazard for drivers. Residents should be advised to wait as long as possible to shovel or clear at the end of their driveway. Also, **when removing your snow, deposit the snow to the right of your driveway as you face the street**. By doing this, when the plow returns, it will carry the snow you moved away from the driveway. Snow placed on the left side will probably end up back in your driveway the next time the plow makes a pass.

Not all of the streets or roads in the township are public. Some are private drives that are maintained by owners, homeowners associations, or developers. We also have many state roads in our Township which are maintained by PennDOT. We are not supposed to plow any part of the state roads, even if we think we are doing a favor. If we plowed a portion of a state road and then turned off onto one of our township roads, a motorist could be driving down the road on that plowed portion (thinking the road has just been plowed) then suddenly hit deep snow, causing them to have an accident where we turned off and did not finish.

**Property owners and/or occupants are responsible for clearing snow and ice from adjacent sidewalks within 24 hours after the end of a snowfall.** Owners or occupants failing to clear sidewalks may receive a citation, be fined and/or be responsible to reimburse the township for the cost of clearing the sidewalk.

Please drive safely, slow down, and allow extra time to reach your destination during winter weather events. This is the most effective way to prevent an accident. Thank you for your cooperation and happy holidays!
