

Whether we like it or not, winter will be around for a while longer. Every property owner in Summit Township must adhere to the following winter safety regulations:

- No parking on Township roadways we can't plow if your car is on the road!
- No plowing or depositing of snow across or upon Township roads.
- Sidewalks must be cleared of all snow/ice in excess of two (2") inches within 24 hours after the snow stops. A path 36" wide must be cleared.

SUPERVISOR'S CORNER

Hello all!

As Treasurer I would like to discuss Summit Townships' budget. A whole year has passed since we relaxed on Covid restrictions. Hard to believe how quickly time goes by. It was a very interesting and scary worldwide pandemic to witness.

I bring this up because all the shutdowns caused by Covid and stay-at-home directives have created a lot of financial problems and inflation for everyone including families, businesses, and the government.

I was not really fond of the stimulus checks because again, in my opinion, money does not grow on trees, and we will all pay for the financial stress and debt for a long time. However, I do understand that the stimulus checks were to help keep the country from shutting down and to buy the economy time to help folks get past Covid. I bring up the financial woes of COVID because it has caused Summit some financial distress too. So, you must watch your budget to spend money wisely.

A few years ago, the Summit Supervisors agreed to increase the Local Service Tax, (LST) for all employees working in Summit. That was because we earmarked that money for the Perry Hi-Way MOU (Memorandum of Understanding), or the agreement to help support the EMS-paid service. The amount is \$52 a year per employee if they earn \$12,000 or more in the calendar year. We have just under 7,400 residents and 14,000 people employed in Summit. Five dollars of the LST goes to the school district each year. So, \$47 a year goes to PHHC EMS. We felt one dollar a week is very cheap to help support a 24/7 EMS service where they travel to work and that it was not fair for the residents and businesses to cover all of this public service. When we had all the closing and shutdowns of covid, it also affected the amount of LST tax we had been counting on to help subsidize the paid EMS service. That amount was approximately \$350,000 annually.

Other budget items are the cost of equipment, material, and fuel. We lost our recycling contractor in 2022 which

brought on a tough process with no easy answers. Therefore, we currently have recycling drop-off dumpsters at the township garage on Old French Road to provide a way for our residents to continue to recycle. Summit Township has always provided and paid for a recycling contractor to provide curbside pickup for our residents even when the township was not mandated to do so. Per our population as of the 2020 census, we are now mandated by the PADEP to provide curbside pickup with the budget figures looking to be doubled from 2022. We have very few vendors interested due to their increased cost to transport the recycling and their lack of staff which will make it very difficult when we go out to bid.

Summit Township is the only township in Erie County that offers The Homestead Act. This Act allows the homeowner that resides in their home to not pay property tax to Summit Township which means this resident only pays Erie County Tax and School Tax. Most residents think some of their tax dollars comes to Summit Township, but they do not.

It's very hard to make decisions sometimes because you try to please everyone. We all have different ideas, so you make the best decisions you can for the good of all residents, businesses, and the township's financial well-being, while still trying to be as fair as possible and not just supporting someone's personal agenda. Being one of three supervisors can be trying too because the majority rules, and usually, someone is not happy. It is not always easy, so you do the best you can.

Our township has grown many times over in the past 45 years, with many changes, and more to come, but I still enjoy living in Summit. I usually avoid the busy retail areas during prime time, when traveling, unless I have to or dining at a local restaurant. Please drive carefully, leave early, and take care.

Hello Summit Township Residents,

As I write this article for the newsletter, we have received approximately 35 inches of snow so far this winter, less than half of our usual snowfall. It is years such as this that I don't mind living in northwest Pennsylvania unlike when I was younger it seemed like we always hoped for the most snow possible, especially if it meant a day off from school.

At any rate, it does seem as though spring is right around the corner which means the parks will open once again, along with the nice weather picnics, outdoor sporting events, and work around the township to clean up anything left behind from the previous season. This year folks will be able to try out the newly renovated basketball/volleyball court that was also intended for pickleball. I am going to be getting quotes for some sort of fencing around the court to aid in keeping the balls inside the play area and hopefully deter bicycles and motorized vehicles from driving on the court which could damage the playing surface.

Also on the list will be a new camera system and Wi-Fi access at Picnicana. Internet service was installed last fall by Spectrum, which will also be a helpful tool to view remotely in real-time any activity that may be taking place at the park. We have had instances where the state police wanted to view our camera footage and could not due to the antiquated camera system currently in use which only works when it wants to.

The exterior doors to the kitchens and restrooms will be painted this spring because many of them have faded and or peeled over the years. Some of the playground equipment will also be freshened up with new paint and hardware. Some of those pieces have been around since the mid-1970s. Pavilion number one did not get refinished last year due to the drastic increase in the cost to have it blasted with glass beads. The original quote was \$5,000.00 with an increase to \$10,000.00 which we felt was not a good investment. I will be exploring other options to accomplish the refurbishment in-house this year.

Lastly, after several years of Covid restrictions, resident's weekend, the senior picnic, and the summer recreation program will be returning this year. I'm certain that everyone is looking forward to life as usual as we begin a new season of sunshine and warm weather.

2023 Stormwater Resolutions

New Year's resolutions offer the promise of a new start and setting positive intentions for the months to come! Managing stormwater is a year-

round practice and as we trudge through the remainder of this winter's snow, ice, and cold temperatures, there's a lot you can do to help make spring snowmelt and summer rains easier on our local waterways:

- Do you have a private well? Have you had it tested? Make sure your drinking water is fit to drink!
 - If you do have a well, is it protected from contaminants? Be careful about pet waste and fertilizers within a 100-foot radius of your well.
- Consider installing a rain barrel to collect water from your roof, or permeable pavement, and/or a rain garden to alleviate wet spots in your yard. This could save you money on watering and prevent costs associated with flooding!
- Use fertilizers and other applied chemicals sparingly as these can have adverse effects on our creeks, streams, and Lake Erie.

- Scoop the poop! Dispose of pet waste appropriately, especially in winter. Pet waste can introduce excess nutrients and bacteria into our waterways.
 - o The same goes for litter and leaks; just because the snow hides it does not mean it is not a problem!
- Assess your home for water-saving devices. Are there any improvements that could be made to leaky faucets this year? This could also save you money on your water bill!

For the year 2022, Perry Hi-Way responded to a record-high number of calls, with a total of 2340 responses. Perry Hi-Way was called to respond outside Summit Township a total of 849 times in 2022. Perry Hi-Way has become the safety net for much of Erie County. The majority of these calls were for Ambulance service into the areas of Millcreek Township and The City of Erie. We also provided regular coverage for Waterford, McKean, Greene, and Harborcreek Townships. 



SUMMIT TOWNSHIP SEWER AUTHORITY

Old Perry Relief Sewer

At the Summit Township Sewer Authority's October 27, 2022, Regular Monthly Business Meeting, sealed bids were opened for the construction of Old Perry Relief Sewer. The project calls for the installation of approximately 1,700 feet of 14" HDPE pipe, and 350 feet of 15" PVC gravity sewers. Two qualified bids were received:

Konzel Construction base bid: \$770,000.00
 Chivers Construction base bid: \$772,010.00

Konzel construction was awarded the bid and began work on January 23, 2023. The Authority received a \$367,415 grant under the Pennsylvania Small Water and Sewer Program with the assistance of Senator Dan Laughlin (PA-49). The project is expected to be completed by June 30, 2023. Motorists traveling on Old Perry Highway in the area between Bloomfield Parkway and Old French should exercise caution when driving through the construction site.

Connection Assistance Project

Also at the October 27, 2022, Regular Sewer Authority Meeting, bids were opened and awarded for the Connection Assistance Project general construction contract. The project consists of 31 lateral extensions comprised of the installation of 14 each, 1 ¼-inch HDPE low-pressure sewer laterals, and 16 each, 6-inch PVC gravity sewer laterals. Three qualified bids were received:

Konzel Construction base bid: \$714,000.00
 XL Excavating base bid: \$815,715.00
 Chivers Construction base bid: \$825,625.00

Konzel construction was awarded the bid and began work on January 30, 2023. The Authority is also proud of the \$343,710 grant received through the Pennsylvania Small Water and Sewer Program. Again, with the assistance of Senator Dan Laughlin (PA-49). The project is also expected to be completed by June 30, 2023. The locations of these connections are scattered throughout the Township. Please be cautious when driving through any construction site.

Oliver Road Lift Station, Force Main, and Gravity Upsizing Project

The work of Contract #3 - Ray Showman Junior Excavating, Inc., for the installation of a prefabricated wastewater lift station, remains paused due to continued supply chain issues. The contractor requested and was granted an extension in time until July 31, 2023.

In addition, Contract #1 - Gravity Upsizing Project, being performed by Terra Works, Inc., is expected to continue in a limited fashion this winter. The Authority has determined that portions of the pipe installed using pipe bursting methods will have to be reworked. We expect the contractor to perform a comprehensive survey, cataloging the defective pipe, to be completed through the winter and early spring. The balance of the pipe installation will be performed using open-cut methods when the weather permits. The project is now expected to be completed by July 28, 2023.

Check your Township calendar for Sewer Authority meeting dates. The Authority office hours are currently 8:00 AM to 4:00 PM, Monday through Friday. Robison Elementary Government Lesson

In early December 2022, I had the privilege to visit Robison Elementary and address the third-grade classes. They had just finished learning about the three branches of government and the function or purpose each branch has. As in previous years, my focus was on the courts.

After a brief overview of the role each branch plays in our system, I presented the class with a hypothetical municipality and a new law that council approved and the mayor through the police force was in charge of enforcing. Simply put, the law stated: "No vehicles in the Park." The class was then broken



up into small groups. Each group was presented with a different fact scenario and was to act as judge on the case to decide if the defendant should be found guilty of violating the law.

After discussing the scenarios in their small groups, the students then presented their case to the class as a whole. There were no right or wrong answers. Each scenario was designed to encourage discussion and there were facts favoring conviction as well as acquittal. What I believe the



students took away from the lesson was how difficult but vitally important it is to write good laws.

I was pleased to return to the school after 2 years of absence due to Covid19. The students asked insightful questions. I must compliment the parents and teachers at Robison, specifically Mr. Chrispen, Mrs. Devine, Mrs. McGowan, and Mrs. Zimmerman. I look forward to visiting them again next year.

FROM YOUR SUMMIT TAX COLLECTOR:

Greetings to All!

I hope everyone had a nice holiday season and now we either get out and enjoy the snow and cold or cozy down and wait for Spring!

In 2022, collections were at the highest in my 17 years collecting Summit Township real estate taxes! A round of applause to you, the taxpayers. Sometimes I know it isn't easy as we never know what life throws at us in any given moment, but you did it! To those residents we have lost over last year, I will miss you.

The 2023 County-Township tax bills are issued and mailed March 1st. March 1st is also when regular office hours resume. Erie County has a new contract with our printer and now part of the contract is that the tax bills are inserted into envelopes right after printing at their facility. This is to ensure that all of Erie County is mailed in a timely manner with the least amount of wasted steps. Therefore, you might receive multiple bills separately. Those that have ten or more parcels mailed to the same address should be received in one envelope. Please make sure you receive all your tax bills. Although mailed the same day, some bills may be received on another day. We mail via the United States Postal Service and have no control on the delivery. You can always contact me and I can provide you with any bill you may be missing. On the same note, sometimes I do not receive your payments through the mail for whatever reason. I highly encourage using the lockbox next to the office door at any time for your payments. This ensures the bill is received and can be dropped off anytime day or night. The lockbox is checked several times a day. I can either email you a receipt when your email is provided or enclose a S.A.S.E.

You can pay multiple bills with one check if you desire. All checks/money orders should be payable to "Summit Twp. Tax Collector." Mills remain the same in 2023 with County at 5.96 and Township at .59. If you write your phone number on your check, I can contact you if there is a problem. Otherwise, I must mail the incorrect payment back to you and you could lose the Discount or Face period, whichever we are in.

If you are in need of a receipt for filing the PA 1000 (Property Rent Rebate), please either email me your request (this has the quickest response time), send a request with a SASE, or stop in the office during regular office hours. If you obtain a receipt for 2023 when paying your taxes, this eliminates having to contact me for the previous year.

As always, I look forward to seeing everyone March 1st. Please contact me with any questions or problems you might have. If you leave a message on the answering machine and it is Monday through Thursday, I will return your call no later than the next day. Messages left on Friday, Saturday, or Sunday will be returned on Monday.
