Motion by Welka, seconded by Hiles, to approve the proposed Orphaned Stormwater Facility Grant with the addition of who to submit documentation to. Vote: 5/0

Chris Groner from the Erie County Redevelopment Authority (ECRDA) was present to discuss a potential loan opportunity for Erie Sports Center through the STIEDA low-interest loan program. Mr. Groner stated that even though the park does not have 3 years of documentation which is normally required for loan approval, he feels the current financial status and future capital improvement plans for the park make it an investment worth considering.

Troy Bingham from the Erie Sports Center was also present to explain to the Board exactly what those capital improvement plans were. Mr. Bingham explained to the Board some programs and facilities that will be added to the center in the very near future which will provide sustainability for the center. He also stated that these programs and facilities will bring people from all over the world to the Erie Sports Center, which will benefit the entire community. Mr. Bingham said that the center is asking for a 1.5-million-dollar loan for a term of 10-15 years at a 1% interest rate to assist with the cost to implement these. Chairman Krasinski stated that although he is excited about the changes and additions coming to the center, the largest loan STIEDA has ever offered was \$500,000. Board member Nesselhauf stated that the low-interest loan program was created with the ECRDA to provide non-biased loan decisions and that the interest rate was determined by the ECRDA. Discussion ensued with Solicitor Wachter suggesting that Erie Sports Center work with the ECRDA to develop a more complete financial understanding and that the ECRDA return to STIEDA at such point that a recommendation is developed. The Board agreed that these steps were appropriate.

The STIEDA Scholarship Agreement with the Fort LeBoeuf Foundation currently provides up to five recipients a \$1,000 scholarship with \$500 presented at the Fort LeBoeuf High School spring awards ceremony and the remaining \$500 released after the recipient provides proof of a 2.5 GPA minimum of their first college semester. Board member Nesselhauf asked if the board would consider removing the GPA requirement and awarding the scholarship recipients the full \$1,000 at the spring awards ceremony.

Motion by Nesselhauf, seconded by Welka, to remove the GPA requirement from the STIEDA Scholarship Agreement with the Fort LeBoeuf Foundation. Vote: 5/0

With no further business to come before the Board, motion was made by Lee, seconded by Welka, to adjourn the meeting at 8:14 p.m.
