Hello all, I recently have been asked what a supervisor does, even by youths, so I would like to try my best to explain. This is important information. First, a supervisor's job can be challenging because it is very hard to make everyone happy when making decisions.

Supervisors set a township's annual budget to decide where and what the money will be spent on and managed annually. They manage all the township employees, administrators, two public parks, senior center, lawn, property, and building maintenance. Other responsibilities are road maintenance, traffic lights, snow plowing, public meetings, and maintaining all the trucks and equipment.

We also make many decisions on land development, zoning, traffic studies, future expansion, and signage. That can be very difficult because many do not like our ordinances, but they are designed to work for most of our township.

Summit is a very busy municipality, and I will tell you, we have a very clean and well-organized township. Many thanks to past supervisors for their help in development over the years. Not always popular decisions on issues to some investors and residents. The ordinances that many do not like are mostly public complaint driven. Having a clean township and getting along is in everyone's best interest.

There are a tremendous number of businesses like retail shops, restaurants, hotels, commercial, industrial, casino, and a landfill. We have many subdivisions, four mobile home courts, and five condo associations. The public must be aware of private roads and HOAs when investing in real estate at these locations. Private roads are mostly built substandard to a municipality's specifications. If they are constructed and coordinated with the township engineer and township specs, they can be taken over by the township when completed, if approved by the township engineer. This is always an issue when narrow sub-standard roads start to fail as years pass. Same as large commercial parking lots. They are not owned by the township.

We have two Interstate Highways located in Summit, centered between three large cities, each within a two-hour drive, that have

contributed to growth. They are I-90 and I-79. This township has 15 multiple-lane traffic light intersections. All the traffic lights and cabinets are owned and maintained by our township 24/7. Our road foreman just checked our computerized grid smart traffic counts. For example, Downs Drive and Peach Street had 39,005 vehicles pass by in a 24-hour period on Wednesday, July 19, 2023. That is amazing.

Here are some other facts about Summit Township — per the last County Census, we have 7,400 residents and 14,000 employees. We also share the financial reports at our public meetings for anyone to see. That is public knowledge. Some think we have unlimited funds, and that is not so.

Summit Township supports PHHC EMS paid service, as we should, so our gaming money received is mostly a push. PHHC is very busy because of other Volunteer Fire Departments' shortcomings in Erie County. PHHC is getting worn out. In July of 2023, PHHC answered 50 mutual aid calls out of the township and not just our four neighboring townships. I have mentioned this in past newsletters.

Erie County has had a 911 Recruitment and Retention Committee for about five years now. We usually meet once a month. Many ideas for fixing the shortage of EMTs, Paramedics, and Fire Fighters. Much of that is looking for financial aid, education opportunities, and possible consolidation.

If anyone ever has questions about zoning, buildings, additions, stormwater, or utilities, please call the Summit Township's office to get all the answers you need ahead of time. Summit is signed with BIU building inspectors along with several other townships. They follow the PA State building code and do not go over or above that. This is about public safety and welfare with all buildings and protects consumers against poor quality construction. PA State Building Code is the law, not Summit's idea. Summit Township employees are not professionals in this field. That is why we contract one.

Thank you, Joe, for all your work and effort in providing everyone with delicious corn from Wasielewski farm. The Mario Brothers movie was shown on the big screen with popcorn and snacks; it was a successful picnic for sure. Hopefully, it can return to a 3-day event next year, as in previous years. I would also like to thank the rec board members for their time and talents in making it all come together.

The senior picnic took place on August 10th this year, and this was also the first time since Covid that we have been able to host this picnic. A special thanks to Presque Isle Downs and Casino and State Representative Bob Merski for their generous donations for the event. It is very much appreciated.

I, for one, would have summer year-round if I could, but we know that is not possible where we live. For now, enjoy the nice weather and your time together with family and friends. We will catch up in the fall.

# Pennsylvania budget focuses on immediate needs, with an eye toward the future

Fiscal stewardship is an art form that requires a blend of persistent planning, hard work, and data-driven strategy. To achieve desired financial goals, you must invest in areas of need, set aside enough to pay bills, and plan for unexpected expenditures that could arise without warning. The 2023–24 Pennsylvania state budget accomplishes this balancing act by investing in critical initiatives that strengthen our schools, assists seniors living on a fixed income, creates an economy that works for everyone, and supports law enforcement.

As an educator, I know how vital it is to provide a solidified educational foundation that will propel the future leaders of our country towards a life well-lived. This budget will invest more than \$10 billion on K–12 public education, including a \$567 million increase in basic education funding. This is the largest increase in basic education funding in the Commonwealth's history.

A critical initiative that will be receiving \$46.5 million in funding is universal free breakfast. This program will provide breakfast to Pennsylvania's 1.7 million public school students regardless of income. Additionally, free lunch will be provided to all 22,000 Pennsylvania students who are eligible for reduced-price lunches through the National School Lunch Program. I am especially grateful to see these programs get the support they deserve. It is unacceptable for students to have to go through their school day without the nourishment they need to succeed, and I plan to work tirelessly to ensure this funding becomes an annual part of our state budget.

The expansion of the Property Tax/Rent Rebate Program is another crucial component that was coupled with the finalized budget. Beginning next year, the newly expanded PTRR Program will provide crucial relief to nearly 175,000 individuals by raising the income eligibility cap to \$45,000 for both homeowners and renters. It is important to note that the income limits for the PTRR program haven't been increased in 16 years; this expansion will help more Pennsylvanians stay in their homes by providing needed financial relief.

To connect Pennsylvanians with a career that allows them to chart their own course, this budget invests \$23.5 million in workforce training and vo-tech programs. It also seeks to broaden the availability of apprenticeships through a \$6 million commitment. Focusing on providing appropriate training so individuals can pursue these types of careers diversifies and expands our workforce while helping individuals without a college degree pursue alternative options for family-sustaining employment.

The continual support of law enforcement was once again prioritized in the agreed-to spending package: \$16.4 million will be earmarked for training nearly 400 new Pennsylvania State Police troopers. Additionally, the Violence Intervention & Prevention Program, administered through the Pennsylvania Commission on Crime and Delinquency, will receive \$40 million in state funding. This program is vital in our continued efforts to reduce gun violence and make our communities safer.

This is a brief overview of the good-government initiatives that are being bolstered in this year's state budget, all while holding the line on taxes. I see this budget as a reflection of our priorities and look forward to continuing to champion an agenda that benefits everyone throughout the Commonwealth.

### **RESIDENTIAL FUND DRIVE 2023 IN PROGRESS**

Just a reminder...the 2023 residential fund drive is still in progress. To date, we have received contributions from just 27% of our residents. The cost for emergency services should be shared by all residents and not just the residents that have donated. There is currently no fire or EMS tax levied in Summit Township at this time. For those who have given, we thank you. For those who have not yet sent in their 2023 donation, we ask you, please send that donation today. We ask for just \$75 per home for an entire year of emergency service protection or less than \$0.21 per day. For those who have a tighter budget, please send in what you can afford, and for those with a little more generous budget, we THANK YOU! Your donations are used to help meet our operational expenses. Checks can be made out to Perry Hi-Way Hose Company and sent to the Oliver Road Fire station at 8281 Oliver Road, Erie, PA 16509. By working together, we can make sure emergency services in Summit Township are available when needed!

### **AMBULANCE UPDATE**

In the last newsletter, we discussed the limitation of ambulance assistance to Millcreek Township and The City of Erie. The State Department of Health, the agency that licenses ambulances in the state, has refused our request to limit our response areas. The state has made it clear that we are not able to limit our response areas, and failure to respond to these areas when called to respond by the 911 center will result in removal of our ambulance license. While this is the way the law is written, it does not make it right. We have consulted an attorney on this matter and found it would be too costly and take too much time to try and fight the State. Not to mention, we do not want to lose our ambulance license. We are working with the Erie City Council and the Millcreek Township Supervisors to try and work out some funding solutions to our issues. We hope to see some assistance

### **AMBULANCE BILLING REMINDER**

I am reviewing the ambulance billing procedure for Perry Hi-Way Hose Company again in this issue to help clarify for some residents. If Perry Hi-Way Hose Company provides ambulance service to you or a family member, a bill is sent to your insurance company. We accept what the insurance companies pay for our service, even if it is much less than the fees charged. In some cases, even less than the actual cost of providing the service. This is a benefit of living in Summit Township.

Some insurance companies (Highmark, for sure) will send the patient the check and not send it to Perry Hi-Way or our billing agent – Quick Med Claims. If you get an insurance check sent to you for ambulance service, please forward it on to Perry Hi-Way or our billing company ASAP so it can be credited to your account.

There may be times our billing company needs further information for billing your insurance company or a secondary insurance company. Please get the information back to them ASAP as well so we can get your claim paid and closed out.

With today's high deductible plans, many people fall into the situation where they have not met their deductible and are responsible for paying the bill. We can offer a discount to residents to help with this cost. If this is your situation, please contact the fire station (814-864-0680) with patient's name and date of service, and we can work with the billing company to offer this discount.

The cost to maintain the fire and ambulance service for the township is constantly on the rise. We rely on the ambulance billing income to keep our emergency services for the township the best they can be. As a reminder, the operational budget for this year was \$544,000, plus the cost of the paid staffing being an additional \$880,000. This totals just under \$1.5 million annually to provide emergency services to the growing and aging Summit Community.

September: National Preparedness Month Tips

- ✓ Include cash in your emergency supply kit. During an extended power outage, ATMs and credit card machines may not work.
- ✓ Check-in with neighbors to see how you can help each other out before and after a storm.
- ✓ Pick an out-of-town person for everyone to contact during an emergency.
- Preparing your family for an emergency is as simple as having a conversation over dinner. Remember to include your pets in your family's emergency plans. Make a plan tonight.
- ✓ As part of your family's emergency supply kit, include games and toys to keep children entertained.
- Get prepared by having an emergency supply kit already stored. #ResolvetobeReady www.ready.gov/build-a-kit
- Snap some pictures of your property and make an inventory for insurance purposes. Take a current photo of you and your pet together in case you get separated during a disaster. #ResolvetobeReady #PetPreparednesswww.ready.qov/animals
- Make a list of the things you would need or want to take with you if you had to leave your home quickly.
- Prepare your car for winter: keep your gas tank near full to help avoid ice in the tank and fuel lines.
- Make a plan to check on neighbors if extreme cold or winter weather knocks out your power.
- ✓ Learn how to shut off the utilities where you live, including water, electricity and gas.

### FROM YOUR SUMMIT TAX COLLECTOR:

Hello All!

It's hard to believe, but it is time for the third quarter newsletter! Soon it will be back to school. I think parents and children will be happy to see that come.

All taxes for 2023 have been issued and mailed. That includes 2023 County/Twp, School, and any Interims, if applicable. If you have not received any of your bills, please contact the office. As you may have noticed, delivery of the tax bills has been different than in previous years. The contract that Erie County Assessment (they are responsible for the Tax Rolls and delivery of the data to the printer) has with the printer includes not only the printing of the tax bills but insertion of the tax bills into the envelopes. This is to ensure that all tax bills for the County and School Districts are mailed in a timely manner. The printer cannot group multiple bills in one envelope as before. Therefore, if you have multiple parcels, they will be sent in separate envelopes. If you do not receive all your parcels, please wait a few days and then if not received, contact the office and I can email you a copy. The same goes for payment of tax bills. As the delivery of mail can be unpredictable, as pay periods are close to ending, dropping your payment in the lockbox might be a better idea than sending through the mail.

I have been receiving numerous calls regarding the School Per Capita Bill. These are collected through Berkheimer. The School District maintains the per capita listing. Per Capita is paid by ALL residents from 18 years and up. The only two exemptions are if you are under 18 years of age and your total income from ALL sources Is LESS than \$10,000.00 per year. You must complete a Fort LeBoeuf School District Request for Exoneration of Per Capita Taxes through the FLB School District Administrative offices at 814-796-2638. If you qualify for either of these exonerations, it is not automatic. You must contact the school administration offices. Berkheimer also

has a local office at the Millcreek Municipal Building. Their number is 814-833-4870. Other than providing you with this information, I have nothing to do with the per capita taxes.

I have had a much larger than normal number of payments being returned NSF (non-sufficient funds). PA statutes state a person commits the criminal offense of passing a bad check if he or she "issues or passes a check or similar sight order for the payment of money, knowing that it will not be honored by the drawee." I post your payments within 3 days of it reaching my office, not counting weekends. Once this is posted, it can take up to ten days for me to be notified of a returned check. Most monies are already turned over to the taxing authorities. This creates a huge problem. I am charged the NSF or returned check fee for uncollectible funds in the tax collector bank account. Summit Township Ordinance #2017-01 allows me to collect any service fees associated with the returned check. YOU ARE RESPONSIBLE for these fees, and it is stated on your tax bill. If you have made a mistake, contact me immediately to prevent any further problems. Putting your phone number on your check can significantly reduce problems by allowing me to contact you directly.

### PICNICANA PARK 2024 SEASON RESERVATIONS

Picnicana Park is open from May 1st to October 15th, with fully equipped kitchens and pavilions available for rental. Reservations for the 2024 Season will be taken beginning September 15th for Summit Township Residents and on October 1st for non-residents, starting when the Municipal Building opens at 8:00 a.m. Reservations will be accepted on a first-come, first-served basis. There will be a number system placed at the front doors and all residents are asked to remain in their vehicles until their number is called. The Municipal Building will not be open prior to 8:00 a.m. These reservations are for Township resident picnics and do not include any company picnics or picnics being booked for non-resident relatives or friends. ### **Drought Watch Declaration**

On June 15, 2023, Governor Josh Shapiro announced a drought watch for the entire Commonwealth.

On July 27th, following a meeting of the Commonwealth Drought Watch Task Force and the Department of Environmental Protection (DEP), a decision was made to continue the drought watch.

Under the watch, consumers are encouraged to participate in a voluntary reduction of water use by 5% to avoid more stringent restrictions should levels continue to decrease. This is for all consumers, regardless of your water source.

These declarations aren't based on one indicator alone, such as rainfall. The DEP assesses data on precipitation, stream and river flow, groundwater level, and soil moisture, as well as information from public water suppliers.

### **IRON AND MANGANESE IN WELL WATER**

Our water supply includes both surface water and groundwater sources. Both are good quality and are tested to always maintain compliance. Water is very good at dissolving basically every element known to man. Fortunately, our sources provide very good water quality.

Iron and Manganese are minerals that naturally occur in rock, soil, groundwater, surface water, and food and are a normal part of the human diet. As water percolates through soil and rock, it can dissolve minerals containing Iron and Manganese and hold them in solution.

Iron and Manganese can settle out and build up on the pipe walls in areas where the water flow is slower. Then, when there is an increase in water flow through these pipes, there is a chance of the water getting stirred up and becoming discolored. The Water Authority performs large flushes to maintain the water mains and decrease any buildup throughout the system.

Following a large flush in your neighborhood, we recommend that customers also flush their individual services using cold water and before the water enters any filters that you may be using.

The Water Authority takes weekly samples, as regulated by the DEP, to ensure that the drinking water standards are being met.



### **SUMMIT TOWNSHIP SEWER AUTHORITY**

### **CONNECTION ASSISTANCE PROJECT**

The Summit Township Sewer Authority recently completed 31 lateral stubs at various locations scattered throughout the township. The project was conceived in 2016 and was ultimately awarded a \$343,710 grant on August 17, 2020. The original project cost, including engineering and inspection, was estimated at \$416,130. However, at the September 2022 bid opening, the cost was \$804,848, not including engineering or inspection. Unfortunately, the Commonwealth of Pennsylvania Finance Authority awards grants based on the engineer's estimates, submitted at the time of the application, not actual bid costs. The bids were rejected and rebid in October when the low bid was \$714,000.

The Authority recognized many unique circumstances surrounding the project and took action to offset these unique cost increases. Additional contributions by the Authority were authorized by the Board at the July Regular Business Meeting. In the end, in addition to the original Pennsylvania Department of Community and Economic Development grant of \$343,710, the Authority contributed \$244,581 in American Recovery Plan Funds and \$52,667 from Summit Township Sewer Authority Capital Reserve Plan Funds. The final total from other funding is \$640,958, or 75.5% of the total project cost.

As with all projects, each homeowner is responsible for paying for a portion of the project, other associated costs, and the connection from the home to the stub via your lateral. Every effort was made to limit the project cost, and the Authority believes it was a worthwhile endeavor.

## PRIVATE ON-LOT SEWAGE DISPOSAL AND PUBLIC LATERAL REPAIR LOANS — PENNVEST FUNDING!

PENNVEST, in cooperation with the Pennsylvania Housing Finance Agency, provides low-cost financing to improve, replace, or repair individual on-lot sewage disposal systems or to connect, for the first time, to public sewers to meet public health and environmental safety standards.

All homeowners of the Commonwealth who are first-time hook-ups to community wastewater collection and treatment systems and meet the program criteria are eligible. Detailed eligibility requirements can be obtained by contacting the Pennsylvania Housing Finance Agency. See contact information below.

Funds may be used for: rehabilitation, improvement, repair or replacement of an existing on-lot system or sewer lateral located from the house to the main line on a single-family, owner-occupied property which is the primary residence of the owner. Project costs may include design costs, construction fees and costs, permit fees, and most loan origination fees. Loans are up to a maximum of \$25,000, with an interest rate of 1.75%, and up to a maximum of twenty years term.

Other notable terms are construction MAY NOT begin prior to receiving loan approval. Project construction costs incurred before loan approval are not eligible. Also, loan repayment commences within sixty days of loan closing. Please know the loans must be secured by a mortgage lien on the borrower's home, and the loan must be immediately repaid if the property on which the project is located is either sold or transferred.

### **ENGINEER'S REPORT**

### **Stormwater Management Success Story.**

For years the intersection of Ball Park Road and Old French Road was subject to localized flooding during heavy rain events. At times, the floodwaters would crest Old French Road creating hazardous conditions for the road users. The township took mitigation efforts to help with the flooding, including utilizing the underground detention basin at the garage complex in reverse to reduce water levels.

In 2018, the township was mandated by the Pennsylvania Department of Environmental Protection to implement water quality improvements within the LeBoeuf Creek watershed. We used this opportunity to help with the flooding issues at Old French Road. To meet the water quality mandate, we needed to construct a rain garden. A rain garden is a stormwater management facility that detains the runoff and filters the water through a specialized soil mixture with deep-rooted native vegetation to remove sediments and nutrients from the runoff before discharging into the storm sewer. This is done by pooling 6" to 8" of the runoff and forcing it to infiltrate through the soil. Beyond that, the rain garden was constructed deeper, and by limiting the pipe sizes at the discharge, we were able to hold more runoff from larger storms.

The rain garden and storm sewer leading to it were designed to intercept as much runoff from Community Park as physically possible, which at the time flowed down Ball Park Road and into the stream leading to Old French Road. From there, the main discharge from the rain garden goes into an improved storm sewer that runs between the garage complex and the park into the garage complex's underground detention basin. This underground detention system was originally designed for a full buildout of the Old French Road Township Complex, including the Municipal Building. As such, it was underutilized. By directing the runoff this way and detaining it twice, it would significantly slow the runoff down prior to reaching the trouble spot. This, in turn, would reduce the peak flow at this location.

Since the rain garden has been installed, the frequency and severity of flooding in this location have been reduced. On July 28, 2023, a significant storm cell went through the area. We measured 1 inch of rain over a 15-minute period, equating to a 10-year storm event; however, the maximum intensity measured was over 12 inches per hour, which is over a 1,000-year storm intensity. After this rain event, there were reports of localized flooding throughout the township; however, there were no reports of flooding in this area.





### **MASTER WATERSHED STEWARDS**

The Master Watershed Steward Program educates and empowers volunteers to protect environmental resources. After receiving 40+hours of training, Master Watershed Stewards give back to the community by offering educational opportunities, collecting citizen science data, organizing clean-ups, working on wildlife habitat and stream restoration projects, and more. 


