## SUPERVISOR'S CORNER

Hello All.

As I am writing this, it is 33° out, with another inch of snow. Hopefully, spring is coming sooner than later. This has been a longer winter than I care for. Things are going well with the Township, and I hope they are going well for all our Summit citizens. We are planning more projects for this year. Keeping up on the township properties, maintenance, and upgrades; more brick and roof work to come.

Message on REAL ID. With only a few weeks left until the May 7, 2025, federal enforcement deadline, PennDOT continues to offer REAL ID Days events across PA to give residents additional opportunities to get a REAL ID. The events so far have been popular, with over 7,000 residents who have attended. I have not done this myself. PennDOT's Driver License Centers are now equipped to verify these documents for customers who want a REAL ID. All documents MUST be original versions or certified copies (if applicable) — no photocopies will be accepted. Try this link, <https://www.pa.gov>, for more information and type 'REAL ID' in the search line.

Recently, I put together a 10-hour OSHA class for eleven of our road crew members. They had never had any formal training on safety.

Hello Summit residents,

Our road crew has been working on yard damage and fixing potholes throughout the township. The new and improved plows did not work out as well as we had hoped and are being reengineered as we speak. They did not work well for our narrow roadways and soft berms. Please be patient as we have two backhoes out working on our 50 miles of roadways.

Jumping ahead to our Capital Improvements for this year:

We intend on paving the Trails at Five Points, Hamot Road from I-90 to the roundabout, Footmill Road from the Millcreek

Hello Summit Township residents,

As I write in this newsletter, the weather has certainly changed from the last time. It is 50° and sunny. The buds are on the trees, and the flowers are starting to pop out of the ground. Hopefully, winter is over.

It has been a busy winter with some upgrades made to the Senior Center, made possible by a generous \$31,684.49 donation from Presque Isle Downs & Casino. I would like to thank Gary Hendricks, the General Manager, and Matt Ennis, Senior Director of Operations, for their efforts in making this fundraiser possible. A new oven that can hold enough food to feed 70 people was installed, and the kitchen floor was replaced, thanks to the hard work of two of our road crew members, Darrell and AJ.



They do work in some dangerous conditions and must be aware of their surroundings. I have had OSHA 10 and OSHA 30 certifications and have also been an instructor. This is a great class for safety awareness that covers a broad range of construction projects, even at home. Such as Focus Four: Struck by, Electrocution, Confined Space, and Falls. Our road crew employees do it all. They work in ditches, manholes, storm and sanitary sewers below ground, on ladders, road work, and operate heavy equipment. This education could easily make people think about their actions and help prevent injuring themselves and fellow employees, or worse. I have worked in construction since 1977 and have seen many injuries and two casualties caused by careless acts. No one needs that, and everyone deserves to go home safe and healthy at the end of a workday.

One more message: PennDOT has started on the replacement of the Jordan Road overpass bridge on I-90 just west of Station Road near Penn State Behrend. This is a nine-month project that will impact the traffic on the I-90. Please be aware of potential delays during your travels.

## SPRINGTIME STORMWATER

With spring finally upon us, stormwater will again be more noticeable in the Erie County communities along with litter, oil slicks, and other pollutants that tend to populate our streets. Because stormwater can carry these hazardous materials into our waterways and affect such resources as drinking water, it is important to consider ways we can personally improve local water quality. Even those of us with seemingly insignificant yards can make a huge impact!

As spring progresses, consider engaging in these activities to improve the water quality of stormwater where you live:

- Dispose of any wind-strewn trash from this past winter and fall, including missed organic matter like leaves and grass clippings.
- Test the soil in your lawn to better inform your fertilizer needs and minimize excess waste runoff into local waterways. If you do use fertilizers, seek out slow-release nitrogen fertilizers to further minimize harm to water quality.
- Mow high (about 2.5 inches or more) to allow your lawn to retain moisture and promote dense growth. Allow any grass clippings to decompose on your lawn. This is free fertilizer! Sweep any clippings off impervious surfaces such as a driveway onto your lawn so that they may avoid becoming runoff pollution.

For the more adventurous out there, consider reimagining your lawn altogether!

- Plant native meadow grasses instead of traditional turf, even just to replace a bare planting bed. Native plants have deeper roots and are better adapted for the local environment than turfgrass and also provide a microhabitat for insects, birds, and other wildlife.
- Planting native trees and shrubs provide further water quality improvement and doing so along the periphery of your lawn—along fences and other boundaries—reduces mowing space, saving you time and money.
- Install a rain barrel, redirect a downspout into a planting bed, or install a rain garden. There are many things we can do to create a more watershed-friendly and aesthetically pleasing green space at home.

## FROM YOUR SUMMIT TAX COLLECTOR:

Welcome Spring!

The 2025 County/Township bills were mailed March 4. If you have not received a tax bill by now, please contact the office. The County/Township tax bills will be in the 10% penalty phase beginning July 1. The tax collector cannot waive the 10% penalty even if you did not receive your bill. It is your responsibility to update your mailing address with Erie County Assessment. You may stop in this office during normal business hours to obtain a Property Record Correction Card OR you can email them the change at: [assessmentinfo@eriecountypa.gov](mailto:assessmentinfo@eriecountypa.gov). You must include your name, address of your home, property description, parcel ID number and new mailing address. Your parcel ID number is right under the barcode and starts with 40. Use this format 40-000-0000-00000. Make sure to include all period marks. A property description is found on your tax bill on the right-hand side of the bill under the notice in red at the top of the page. Most times, this will be the same as your home address. All tax bills are mailed at the same time. Once they are mailed, I have no control over their delivery. If you are having issues getting your mail, please contact your postal carrier or contact the USPS. To ensure receipt of your payment, I suggest either paying in the office or using the lockbox to the right of the office door. There is a pencil inside to mark down your phone number. Payments are processed within 5 days.

The income guidelines have been raised for the PA 1000, a.k.a. Property Rent Rebate. A stamped receipt from the tax collector showing paid is required to file. Again, unless you are escrowed, you should be obtaining your receipt when making payment. You should enclose a SASE in the lockbox or if sent through US mail. If you are escrowed or have lost your receipt, you may obtain a receipt by stopping in the office during normal business hours or request through the email stated on your tax bill: [summittaxcollector@yahoo.com](mailto:summittaxcollector@yahoo.com).

The 2025/2026 School bills will be mailed July 1. If you do not receive your bill by July 11, contact the office for a duplicate. The FLB School District budget is passed in May. I will know if there is a mill increase at that time.

One important note for those that have a mobile home... In order to transfer a title, you **MUST** have the current year tax receipts showing PAID and a Tax Lien Certificate from Erie County Tax Claim (814-451-6206) showing no back taxes. A title transfer cannot legally be done without these documents. An Erie County Manufactured/Mobile Home Change of Ownership Form (must be notarized) needs to be filled out and sent to Erie County Tax Assessment. You can find the address on the form. This is the **ONLY** way the tax roll is changed. Transferring a title does not transfer the tax roll. If a Tax Lien Certificate from Tax Claim is not produced, and later it is found that back taxes were due, they become **YOUR** unpaid taxes.

# Perry Hi-Way News

**HAPPY SPRING!** Let's hope the snow that Mother Nature dropped on us this past winter is finally done. On the plus side, this winter was great for those who ski, ride snowmobiles, Ice Fish, and participate in other winter activities. Our plow truck, as well as the Township plow trucks, sure got their use and abuse (snowplowing is a rough use) this winter. Just as always, the sun came out to shine, and the temps rose to melt off the white blanket of snow. With that, I sure hope that the mud has dried, the grass has started to green up, and the salt is off the roads by the time this second quarter newsletter is delivered.

The start of May means the start of the flowers beginning to come alive and the buds on the trees and plants to pop out. May 1st also starts the annual residential Fund Drive Campaign for the Perry Hi-Way Hose Company. The fund drive provides money to meet our operational costs, such as fuel for our emergency vehicles, utility costs, vehicle and liability insurance, vehicle maintenance, station upkeep, and ambulance supplies, just to name some of our bigger expenses. While the Township Supervisors continue to provide a large amount of funding from the LST funds and casino funds, the vast majority is used to pay for the paid staffing wages and benefits, totaling more than \$885,000 for this year. **THERE IS NO FIRE TAX LEVIED BY THE TOWNSHIP AT THIS TIME.** Your donations are needed to keep the department open and in operation. It is disappointing that less than 1/3 of the residents donated to the services that we stand ready to provide should an emergency occur. We ask for just \$75.00 per home or less than \$0.21 per day to support the emergency services for Summit Township. The fund drive mailer will be sent the first week of May, and all residents should have it in their mailbox by May 15th. Please return your donation in the small envelope provided to show your support of this vital service. If a fully tax-based fire and EMS system was put into place, the cost would be much higher than \$75.00 per year. A small force 1/5 the size of the City of Erie would cost an estimated \$4,000,000 per year or over \$3.00 per day per Summit home. Watch your mailbox for your 2025 fund drive letter.

Perry Hi-Way is adding an additional Ambulance to the fleet. This additional ambulance will be used as a reserve unit. Currently, when one of our ambulances goes out for service, this new unit will be put in service. This will ensure we maintain 2 ambulances in service from 9am to 9pm daily. These hours are our busiest times when we have 2 crews on staff. We have purchased a used ambulance and are having the ambulance box placed onto a new 2025 Dodge 5500 chassis. The new chassis replacement will save us \$175,000 vs purchasing a brand-new ambulance. We hope to have this new unit ready for use by mid-July 2025. The chassis replacement is being completed locally by Kolaja Fire Equipment Company in Union City, PA.

A big thank you goes out to the staff at the club who sprang into action and had the person revived before our arrival. Staff started CPR and used their AED (automatic External Defibrillator) when the person went down. The staff provided 2 shocks from their AED, which got their heart started again. Our crew then stabilized the patient and transported them to the hospital.

This Case shows the importance of rapid application of CPR and use of the AED by the public on people who suffer from sudden cardiac arrest.

These new members are completing their training on our equipment and procedures and will be on the schedule as full-time crew members starting April 1.

Till the next quarter, be safe. Keep smoke detectors in working order, no texting while driving, be careful not to burn yard debris on dry, windy days, and have a hose or water supply to handle any fires that get out of hand. Keep your hands/fingers away from the operating lawn mower blades.



## PennDOT, Safety Partners Warn Against Distracted Driving

**PUBLIC SAFETY MESSAGE. NEW HANDS-FREE LAW GOES INTO EFFECT JUNE 5, 2025.**

Please consider not handling a cell phone while driving. Very dangerous and once you have a serious accident from a cell phone distraction, it's too late.

According to PennDOT data, there were 11,262 crashes statewide involving a distracted driver in 2023, resulting in 65 fatalities. In the northwest region, which includes Crawford, Erie, Forest, Mercer, Venango and Warren counties, there were 540 distracted driving crashes and six fatalities.

To help combat distracted driving, Pennsylvania will soon implement "Paul Miller's Law," which prohibits, as a primary offense, any driver from using an interactive mobile device while driving. The law is named after Paul Miller, who was tragically killed in a crash with a tractor trailer in 2010 in Monroe County as the result of a distracted driver who reached for their phone.

Enforcement of the law begins on June 5, 2025, and the violations during the first 12 months will result in a written warning.

Effective June 5, 2026, the penalty for violations will be elevated to a summary offense with a \$50 fine, plus court costs and other fees. "Under this new law, we will be able to pull over drivers who are observed with a mobile device in their hand while driving," said PSP Troop E Community Services Officer Todd Bingman. "There are limited exceptions for drivers to use their phones, such as dialing 911 in an emergency or having hands-free technology integrated into the vehicle."

Currently, Pennsylvania enforces a texting-while-driving ban that prohibits drivers from using interactive mobile devices to send, read, or write text-based communications while their vehicle is in motion.

To help avoid distractions from cell phones while driving, PennDOT offers the following tips for motorists:

- If you are expecting a text message or need to send one, pull over and park your car in a safe location. Once you are safely off the road and parked, it is safe to text.
- Ask a passenger to serve as your "designated texter." Allow them to access your phone to respond to calls or messages.
- To resist the urge to look at your phone, place it in the trunk, the glove box, or back seat of the vehicle until you arrive at your destination.
- Put your phone in "driving mode" and enable autoreplies to text messages to inform others that you are driving and will respond when it is safe to do so.

# Improving Accessibility, Safety and Quality of Life

As we say goodbye to the frosty embrace of winter and welcome the warmth and vibrancy of spring, I am eager to share some forward-thinking initiatives that my colleagues and I have been passionately working on—both here in Summit Township and in Harrisburg.

In a significant step toward enhancing community accessibility and safety, Summit Township has been awarded a \$400,000 state grant to improve pedestrian connectivity along Upper Peach Street. This funding, secured through the Multimodal Transportation Fund, will cover two-thirds of the project's cost, with the township contributing the remainder. The sidewalks will connect shops, restaurants, and hotels, making it safer and more convenient for residents and visitors to navigate this bustling commercial corridor.

Construction is expected to begin in 2026, following preliminary work this year. This project is part of a larger plan to enhance pedestrian access and safety throughout the township. Infrastructure improvements like these are vital for fostering economic growth and ensuring accessibility for everyone.

Another milestone is the progress of my bill, H.B. 273, which has cleared the Pennsylvania House Committee on Housing & Community Development. This legislation aims to tackle blight and revitalize neighborhoods across the commonwealth. It proposes the creation of a county property maintenance code, a Municipal Codes Enforcement Grant Program, and a municipal neighborhood mitigation fund.

These measures would provide municipalities with the resources needed to address blighted properties and promote safer, more vibrant communities. As a former city

councilman, I have seen firsthand the negative impact of blight on property values and residents' quality of life. This bill is a step toward empowering our communities to reclaim and rejuvenate their neighborhoods.

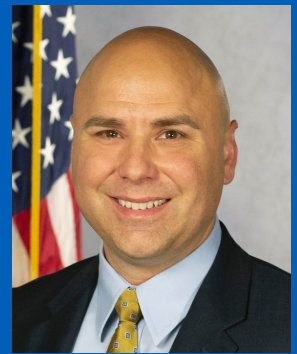
Furthermore, I want to remind residents of the Property Tax/Rent Rebate Program, which offers financial relief to eligible homeowners and renters. This program provides rebates ranging from \$380 to \$1,000, with supplemental rebates available for those most in need.

To qualify, applicants must meet specific age, disability, or income criteria. Applications for 2024 rebates are due by June 30, 2025, with the possibility of an extension to December 31 if funds permit. Residents can apply online via myPATH, by mail using the PA-1000 form, or in person at designated locations, with free assistance available to ensure applications are completed accurately. For additional information, visit the Department of Revenue's website or contact my office.

These efforts are just a glimpse of the meaningful progress we can achieve through collaboration and unity as a community. I am profoundly grateful to everyone contributing to making Erie County a thriving place to live, work and flourish.

# Engineer's Report

The Township received a \$400,000 grant from the Commonwealth of Pennsylvania, Commonwealth Financing Authority, to install sidewalks along the Peach Street Corridor. The project will install approximately 1.1 miles of sidewalk, 21 ADA-accessible curb ramps, and three bus shelters. The primary goal of the project is to fill the sidewalk gaps and make a sidewalk network in this area. We are working in collaboration with EMTA to determine the locations of the bus shelters. We will be starting design and permitting shortly. If everything goes according to plan, we anticipate starting this project in 2026.



The Downs Drive Improvements Project is currently out to bid and is expected to be completed this year. There will be lane restrictions and closures during the construction. We will post updates on the website and our Facebook page as the project progresses. As you may recall, the goals of this project are to repair and reconfigure the existing Downs Drive, west of Peach Street, into a two-lane road with dedicated left-turn lanes, and to remove excess asphalt to make the road more intuitive and user-friendly. The east side of Peach Street will be repaired and repaved. The sidewalk portion of this project was removed and included in the above project in 2026. This project is partially funded with \$250,000 from the Commonwealth of Pennsylvania, Commonwealth Financing Authority.

## **WATER MAIN FLUSHING TO BEGIN IN MAY**

The Summit Township Water Authority will be conducting our annual water main flushing beginning in May. This is conducted by pulling large volumes of water through fire hydrants and improves water quality by creating a higher-than-normal flow through the distribution system. The flow helps to clear the pipes of iron oxide buildup resulting from the corrosion of older pipes. During the flush, customers may notice discoloration of their water for a short period of time.

## **NEW STORZ FITTINGS INSTALLED ON FIRE HYDRANTS**

We'd like to thank the Summit Township Industrial and Economic Development Authority (STIEDA) for funding a joint grant between the Water Authority and Perry Hi-Way Hose Company. This grant has allowed for the purchase of new adapters to be installed on the front connection to all our fire hydrants. Previously, for the fire department to use a fire hydrant, they needed to manually install an adapter to make the connection. With these in place on every hydrant, valuable time can be saved.

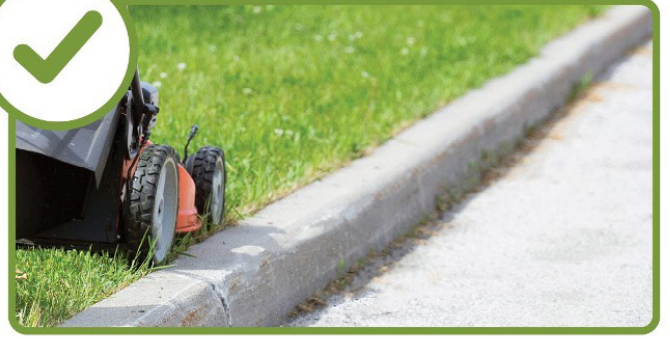

## SUMMIT TOWNSHIP SEWER AUTHORITY

### SANITARY SEWER PROJECT UPDATES

#### Ennis Subdivision Sewer Repairs

Minor restoration work is scheduled in the Ennis Subdivision to address trench settling. One area of pavement near Greentree and another section along a lawn on Laural Drive will be restored. These follow-up repairs are part of a larger project that replaced approximately 530 feet of 8-inch PVC pipe in 12 separate locations and 11 lateral wyes.

If you live in the affected area and notice any new settling or issues with your sewer service, please contact the Authority promptly.

#### Oliver Road Gravity Sewer Replacement (Contract 2021-1)

Repairs to the newly installed sewer line were completed in November 2024 and passed all pressure testing, according to our engineer, Greenman-Pedersen Inc. (GPI).

Due to issues associated with the trenchless technology called pipe bursting, the Authority was forced to abandon proceeding further using this methodology. The EADS Group Inc. has designed a new sewer alignment to avoid the heavily traveled Peach Street corridor. The revised route will cross I-90 near Erie First Assembly, run parallel to interstate I-90, and reconnect at Peach Street near Burger King.

The Department of Environmental Protection has required an updated environmental review for the

rerouted section as a condition of Pennvest funding. This includes a public notice and 30-day comment period.

The Authority extends sincere thanks to RCR Hospitality, Scott's Development, Sister Janet Goetz, and Cracker Barrel for granting permanent easements to allow this project to move forward.

Once Pennvest approves the change orders, construction will begin. We anticipate completion of the connection from Oliver Road to Peach Street within 90 to 120 days after work starts.

#### Old Perry Sewer Relief – Contract 1

All sewer and flume modification work under this contract are complete, pending final restoration. A retainage of \$5,000 will be held until the restoration work is finished.

Check your township calendar for Sewer Authority meeting dates. The Authority office hours are currently 8:00 AM to 4:00 PM, Monday through Friday.
