CORRESPONDENCE

Jake Rouch of the Erie Regional Chamber & Growth Partnership (ERCGP) introduced Brandon Mendoza, who officially assumed the role of CEO in January 2025. Brandon shared his vision for the future of the organization and announced the rebranding of Erie Forward, the Chamber's initiative focused on business recruitment, attraction, expansion, and retention in Erie County. This initiative will now be known as the Leadership Fund. As part of this transition, Brandon formally invited STIEDA to continue its annual \$12,500 investment, in line with its previous support of Erie Forward. He emphasized that the new structure of the Leadership Fund would offer STIEDA the opportunity to participate in and contribute to all strategic planning efforts related to the fund. Brandon also presented an overview of the updated terms and conditions governing the Leadership Fund. In response, STIEDA requested that these new terms and conditions be provided in writing for review prior to making a decision regarding future investment.
