## CURBSIDE LEAF COLLECTION October 27-31

Residents may opt to have their leaves collected curbside during the week of October 27 through 31. To participate, you must register in advance by calling the Township Office at 814-868-9686, ext. 222.

#### **Guidelines:**

- All leaf waste must be placed in clear/ transparent bags.
- Bags should be set out at the curb during the scheduled collection week.
- Clear bags can be purchased from any retailer
- Bags must be kept separate from regular trash and recycling.
- **Do not include grass clippings** in leaf bags.

As an eco-friendly alternative, consider **mulching your leaves** into your lawn rather than bagging them.

Summit Township and Millcreek Township joined forces with PennDOT District 01 to modernize the Peach Street corridors. 360-degree cameras were installed along with new fiber optic lines and upgraded signal cabinets. A green-light-go grant was obtained to fund the project, the first AI technology in our district. Several other districts throughout our commonwealth have had great success with new technology. The camera system makes constant timing changes as the traffic builds. It is amazing how many vehicles travel this corridor.

Downs Drive is now paved and lines are painted. The west side of Downs Drive has been reconfigured, adding more greenspace and less blacktop. This was made possible with a state grant. Lindy Paving provided us with great service. Sorry for any inconvenience this may have caused travelers.

Hello all, I hope everyone's been enjoying this summer. I do not mind the excess heat, especially after the long winter we had. I have been busy helping to solve problems and answer questions. Many meetings, too. Some days, you don't feel like you have accomplished too much physically, but it's part of the job. I spent one weekend helping Perry Hi-Way Hose replace one of the garage roofs. We had plenty of help from the Chief and other volunteers. All the help was appreciated. As I write this, we are less than one week away from National Night Out and Senior Picnic for all to enjoy.

I would like to bring up a couple of things. I've had complaints where many people simply do not understand. Summit Township is very fortunate to be so busy, and unfortunately, to deal with the traffic that goes with it. I try to avoid the retail areas at prime time if I can help it. That works out well for me. The updated traffic lights and timing on Peach Street have shown success. I have heard many good compliments.

Summit's financial good fortune helps our township to be as nice as it is. I still like to be frugal because there are no guarantees. If we ever lose any of our big businesses, budgets will have to be tightened up ASAP, and I would say especially for Erie County. They benefit too. In my lifetime, I have seen many government entities spend grants and gifted money as part of their annual budget. Gifts are a short-term income. If the money feeders leave, you have no more of that income, and your budget is now upside down. That's why it is good to have money in the bank, live on a budget, and not spend more than you need to, because you can. I have always lived within what I can afford.

Summit has the sixth-lowest tax millage (1.09) of 22 townships in Erie County. Also, residents who live in their own home pay no Summit Tax per the Homestead Act since 2009. That is possible because of all the business. We have 7,400

residents, with 14,000 employees working in Summit. That scenario makes a huge difference compared to rural areas and is almost unheard of. We all pay County and School taxes.

PennDOT and Summit Township have recently done tar and chip projects on some of our local roads. I have heard many complaints about tar and chips, but if it is applied correctly, it makes for very good roads. About 3 weeks after, you will have a good, hard surface. The biggest difference is that modern blacktops are not as good as they were years ago. Many of the new products are water-based, to eliminate oils, to be more environmentally friendly. Blacktop overlay costs 80% more than tar and chip, so that is the biggest factor. No one likes tax increases, so tar and chips are much cheaper. In Summit, we have 50 miles of Township roads and 30 miles of state roads.

Reminder, in 2021, with the help of a few road crew members, we built our Veterans Memorial in the courtyard of our Municipal Building. If you would like a personalized brick for yourself or family, we have forms at the office. The engraving cost is \$25 per brick. I install them in the brick walkway. At present, we have more than 150 engraved Veterans bricks. This is a wonderful tribute to past and present vets.

To close, politics and supervision can be difficult at times, because people are quick to criticize and do not respect others. That can be disappointing. A coach told me one time, "remember to stay in your lane, many of the biggest critics need to sweep their own doorstep". Please enjoy the rest of the Summer and be kind whenever you can. It makes life so much better.

Hello Summit Residents,

It certainly was a very nice summer, one of the warmest I can remember. As I write this newsletter, it is 88° and very humid. We have had a rather successful summer season with our parks and facilities. Many picnics and parties were booked at Picnicana this year. #### FROM YOUR SUMMIT TAX COLLECTOR:

#### **Hello Summer!**

Hope everyone is enjoying summer now that it is finally here!

You should by now have received your 2025/2026 School tax bill. If you have not, please contact this office for a duplicate copy. If you are paying in three equal installments, the first installment is due August 31, the second, September 30th and the last, October 31. On your tax bill, the amount of each installment is listed right above the mils on the right hand side. You must pay this amount for EACH installment. Installments received past the listed dates, are penalized 10%. Installment payments are based on the Face amount, not Discount. You can receive a receipt after your last installment payment — please be sure to keep one copy for yourself for this purpose. This is very important as once an installment is posted, I cannot go back and create an original bill. The PA Dept of Revenue will not accept three equal receipts for the PA1000 (Property/ Rent Rebate).

Checks should be made payable to "Summit Twp. Tax Collector" only. My name should not be on the payee line. Please remember to put your phone number on your check so if there is a problem, I can contact you in a timely manner. If there is a problem with your check and I cannot get in touch with you except through the USPS, you may have to pay at the next pay period. I will be accepting payments through the lockbox at the end of Discount which is August 31, 2025. This is checked daily and I do have a security camera recording drop-offs. If you are paying with cash, please call the office to set up an appointment time. The office is closed in September. This is also stated on your

tax bill. You can however, still contact me via email summittaxcollector@yahoo.com or leave a message on the phone. Again, you can use the lockbox for non cash payments.

A couple things that occur on a regular basis — tax bills are not being delivered due to the parcel owner not updating their mailing address information to Erie County Assessment. Assessment sends the tax bill to the last address provided by the parcel owner. If you have a different mailing address, you must contact them. You are responsible for your tax bill whether you receive it or not. Secondly, if your check is returned by the bank for NSF, incorrect account, closed account or any other issue, your parcel is considered unpaid and make good on that check must be received ASAP IN CERTIFIED FUNDS along with the \$25.00 returned check fee stated on your tax bill. If I have contact information for you, I can call you right away. If not, I will send you a letter stating the steps you must take to put your parcel back in good standing.





Although Sarah is not from Summit Township, she is enjoying getting to know the area and appreciates seeing the projects happening throughout the community.





#### **PROACTIVE SEASONAL MAINTENANCE**

With winter on the way homeowners may want to consider taking steps to prevent wintertime sewer backups. Winter weather presents unique challenges to sewer systems, increasing the risk of backups due to factors like freezing pipes, increased water usage during holiday periods, and the faster solidification of grease in cold temperatures.

Here are proactive steps to prevent these issues:

#### 1. Pipe insulation and protection

- Insulate Exposed Pipes: Wrap exposed sewer pipes, especially those in unheated areas like attics, basements, crawl spaces, and exterior walls, with insulation sleeves, heat tape or heat cables.
- Seal Cracks and Openings: Inspect and seal any cracks or gaps around pipes and in your home's foundation or walls that could allow frigid air to enter.
- Protect Outdoor Fixtures: Shut off the supply to exterior faucets. Be sure to disconnect and drain garden hoses.

#### 2. Maintaining proper flow and temperature

- Consistent Indoor Temperature: Maintain your home's thermostat at a consistent temperature, ideally above 55° F, even when you are away, to keep interior pipes warm.
- Open Cabinet Doors: Open cabinet doors in kitchens and bathrooms to allow warm air to circulate around pipes located along exterior walls if you are headed south for the winter.

#### 3. Waste disposal and drainage management

- Always Avoid Pouring Grease Down Drains: Dispose of cooking grease, fats, and oils in the trash rather than pouring them down the drain, especially in the winter as they can solidify faster in colder temperatures and cause clogs.
- Be Mindful of What You Flush: Avoid flushing non-biodegradable items like sanitary napkins, wet wipes, paper towels, and other items that do not break down upon flushing.
- Clear Outdoor Drains and Gutters: Regularly clear leaves, snow, ice, and debris from outdoor drains, grates, gutters, and downspouts to prevent blockages that can lead to water pooling and potentially freezing in sewer lines.

# Fighting Fraud, Fueling Classrooms, and Shielding Our Heroes

As we soak up the final days of summer's warmth and look ahead to the crisp beauty of fall across Erie County, I'm excited to share several initiatives that promise to strengthen our communities—from protecting you against sophisticated scams, to empowering our educators, to safeguarding the health of our first responders. These legislative successes, born of collaboration in Harrisburg, demonstrate our commitment to practical, commonsense solutions.

In early July, Gov. Josh Shapiro signed S.B. 649 into law, establishing digital forgery as a third-degree felony. This landmark legislation tackles the rise of Al-driven scams by criminalizing the creation or distribution of deepfakes designed to defraud, deceive or harm Pennsylvania residents. Whether it's cloned voices targeting older adults or doctored videos aimed at manipulating public opinion, bad actors will now face serious consequences. By equipping prosecutors with this powerful new tool, we're sending a clear message: technology should never be weaponized against our families or our democracy. I have been at the forefront of Al legislation and was proud to vote yes on this bill. I'm grateful to the Senate sponsors and to the governor for championing this critical update to our criminal code.

As our schools continue to grapple with a nationwide teacher shortage, I joined state Rep. Lisa Borowski in championing H.B. 1403, which unanimously passed the Pennsylvania House in late June. This bill would smooth the path for experienced educators returning to the classroom. Under this bipartisan measure, instructors who place their teaching certificates on voluntary inactive status can pause continuing education requirements without incurring fees. When they decide to come back, professional development credits can be earned through in-district in-service days rather than costly external workshops. By removing financial and bureaucratic barriers, H.B. 1403 would encourage veteran teachers—so vital to student success—to rejoin our schools with the mentorship and support they deserve.

We also passed H.B. 1261, a comprehensive response to the threat posed by PFAS, the so-called "forever chemicals" found in some firefighting foams and gear. This bill would set strict safety standards for protective equipment, allocate funding to help fire companies and EMS providers upgrade to PFAS-free alternatives, and hold negligent parties accountable for environmental contamination. By investing in modern, non-toxic gear, we aim to protect the brave men and women who rush into danger on our behalf—and the communities they serve. This proactive approach would

not only reduce health risks for firefighters but also shield our waterways and wildlife from long-term chemical pollution.



These achievements reflect our core belief that government must work smarter and faster to meet emerging challenges. So, the Casino filled out the forms to donate the money to Lions of PA Foundation in care of the Summit Lions on behalf of the Summit Senior Center. On doing this to help the Senior Center, Summit Lions are to use \$4,000 of the money for our four Scholarship winners from the 2025 graduating class. Since this has happened, Summit Lions would like to find an individual in the community to help us change to a 501(c)(3) foundation.

When Matt Ennis with Presque Isle Downs & Casino, and Tony Davis had their first conversation, I wonder if they had any idea how many people they would touch

with this one act of Kindness. Summit Lions would like to commend these individuals.
