It has been a very productive summer for our road crew!

We were able to pave several roads this year, including Hamot Road from the roundabout to I-90. Trails at Five Points received an inch and a half of top asphalt. Downs Drive, both east and west of Peach Street, was contracted out and subsidized with a DCED grant, which also included adding additional green space in the boulevard area.

We have also been working on several small storm sewer projects to upsize infrastructure and improve the flow of storm runoff. There are still many corrugated metal pipes throughout the township that are failing. If you live on a township road and are having issues with your driveway pipe, please reach out to us.

Tree trimming will begin soon to open up sight visibility at intersections. School buses and plow trucks often have difficulty seeing cross traffic, so this trimming is done for everyone's safety. I will do my best to contact residents where trimming will take place.

We will also be in the Valley View subdivision, removing trees for residents who have requested them to be cut down. If you would like yours removed, please call the office. We'll also be doing general trimming throughout Valley View.

Hello Summit Residents,

Hopefully, this finds everyone in good spirits after a great summer and fall season. The parks are officially closed for the year, and plans are in the works for next year.

I would like to take this opportunity to make some points regarding the Fort LeBoeuf School District, specifically Robison Elementary.

The Fort Leboeuf School District is currently considering closing Robison Elementary School located here in the heart of Summit Township. The district is proposing a new school next to Carm Bonito Field in Waterford. The plan would be to combine all three elementary schools in the district. This plan has not yet been approved by the school board. There is time to get informed and get involved.

A little history of Robison Elementary. Minnie Robison was approached by Summit residents to donate her land for the purpose of a school. Residents believed that Summit Township needed a community school. The land where Robison Elementary is located was donated to the school district for that purpose.

Robison Elementary is the largest of the district's three elementary schools and is located in the most populous of the district's municipalities. One-half of the residents of the school district live in Summit Township. According to the most recent US census, Summit grew 11% over the previous one, and we continue to grow with new subdivisions currently in the planning phase.

The increased distance from Summit to the new school will make it harder for parents to attend conferences at the school and for our children to participate in all the extracurricular activities that currently exist at Robison. This will affect our children the most, especially with the longer bus rides.


If the district closes Summit's community school, Summit will lose not only the school but also the gymnasium, two playgrounds, and two ball fields. These community assets will be relocated to the Borough of Waterford. Summit Township residents and businesses account for 72–75% of the real estate taxes the district collects. This plan will remove our community assets and move them to Waterford, using primarily our tax dollars.

There is extensive research indicating that this move will not save costs and that student achievement will decrease in a large elementary school. For this reason and the above, I am not in favor of the plan, as I believe it will be detrimental to Summit residents more than to any other municipality in the district.

These are just facts that I was able to find, and this is only my opinion. This does not necessarily reflect the thoughts of others within the township administration.

# Happy Fall Y'all!

Once again, it is the end of another year! Today as I am writing this, there is a beautiful blue sky, with plenty of sunshine and warmer than normal weather. Let's hope winter is kind to us.

All taxes issued in 2025 are now at 10% Penalty. If you have not paid your taxes by October 31, you should have received a "Final Notice" reminder in the mail, which included the insert below. We seem to be having a lot of issues with delivery by USPS. To ensure that your payments are received by me, I suggest using the lockbox to the right of the office door. If your check is not cashed in 7 days, please contact me!! Also, if you put your phone number on your check, I can contact you immediately if there is an issue with your payment. PLEASE NOTE THE FOLLOWING:

YOUR TAXES ARE UNPAID. THEY WILL BECOME DELINQUENT IF NOT PAID BY 12/31/25

- Payments after December 15 MUST be in certified funds—cash, cashier's check, or money order. Please put your phone number on checks and money orders. Non-certified payments will be returned.
- 2) Payments must be in my possession December 31, 2025. Postmark is not accepted.
- 3) The office is closed November 1 until March 1. This is stated on your tax bill.
- 4) If you are paying with cash, please contact the office for an appointment.

5) You may use the lockbox to the right of the office door at any time.

Delinquent taxes are turned over to Erie County Tax Claim on January 1, 2026. I have deadlines I must meet as required by law, so please follow these instructions. If you have any questions, please either email me or leave a message on the phone. Even though I do not have office hours for walk-ins, I am still working and will get back to you.



# Here We We We Again

**PILOT TRAVEL CENTER** at 8035 Perry Highway recently completed their 7,785 sq. ft. addition to their existing building. Pilot has over 900 locations that serve more than 1.5 million professional truck drivers every day. The Pilot location in Erie offers staple amenities—such as food, fuel, prime parking, and on-site showers—to the truck drivers who keep our shelves stocked and communities running.

**COUNTRY FAIR** at 7650 Old Perry Highway recently completed the process of adding a new diesel service canopy and adding additional parking. Country Fair opened their doors in 1965 with their original location on W. 8th St. The first store concept was selling milk at a store, rather than having to wait from the slow home delivery. The convenience concept took off, and they now consist of over 70 stores across Pennsylvania, New York, and Ohio.

**DUNKIN**' at 7165 Peach Street recently completed renovations to their location. The New England staple has gone through not 1, but 2 major name changes over the years, and more recently added a 3rd name change to their portfolio. They originally opened as The Open Kettle in Quincy, Massachusetts in 1948. Then, just 2 years later, in 1950, they changed their name to the traditionally known, Dunkin' Donuts. In 2019 they dropped the 'Donuts' and are now simply known as Dunkin'.

# Legislative wins, Community Resources, and Help with Benefits

With the holidays approaching — and as we prepare to make lasting memories with family and friends — I'm pleased to share progress on several forward-thinking initiatives we've been carefully crafting, both here at home and in Harrisburg.

A recent crucial milestone was the passage of my bill, H.B. 1418, which has cleared the Pennsylvania House and modernizes our boating laws to address the rapid rise of electric-powered personal watercraft like e-foils and jetboards. This bipartisan measure clarifies which emerging motorized boards qualify as personal watercraft, aligns state rules with U.S. Coast Guard policy, and establishes commonsense requirements for registration, safety equipment, and operator education.

These provisions would require operators to carry vessel registration, wear Coast Guard-approved personal flotation devices while operating, and ensure minimum onboard equipment, such as a fire extinguisher, a sound-producing device, and proper navigation lighting.

The bill also empowers the Pennsylvania Fish and Boat Commission to require boating safety education and requires manufacturers to meet engine cut-off switch standards or obtain Coast Guard exemptions. These measures protect public safety while preserving recreational access to our lakes and rivers. With the House's passage of H.B. 1418, Pennsylvania is catching up with new technology and making our waterways safer for everyone.


# Property Tax/Rent Rebate Program application deadline December 31

# **Perry Hi-Way News**

### PERRY HI-WAY ADDING ADDITIONAL AMBULANCE

Perry Hi-Way has been able to follow the recommendation of the state EMS study from 2023 and add an additional ambulance to our fleet. This new ambulance will serve as a backup and allow us to have two ambulances available for emergencies when an ambulance is out of service for maintenance. In Late September this year, ambulance 427 hit a deer on Route 97 on the way to an emergency call on Donation Road. There was significant damage to the front of the ambulance such that it could not be used. By having a 3rd ambulance, we can maintain the service levels we have been providing. As luck would have it, the deer accident occurred 4 weeks before the new ambulance was ready to be put in service. Our Brothers at the Cranesville Fire Department were able to help us out and loan us their spare ambulance to fill in for ambulance 427 while it was being repaired. If some of you happened to see the Cranesville ambulance on emergency responses in the township, that would be why.

The sk of new apparatus of the sk of new apparat

The skyrocketing cost of new emergency apparatus these last 3 years is just unbelievable. It is not with just one company but all the emergency

apparatus manufacturers. The past 3 years has seen the price for new trucks jump by 38% to 40%. A way to help combat this price increase on the ambulance side is to use older ambulance boxes in good condition and place them on a new chassis. This saves close to 1/2 the cost of a completely new ambulance. Perry Hi-Way was able to purchase a used ambulance with a good box that meets our needs for \$3000.00 and then have the box put on a new chassis. This was able to be done locally by Kolaja Fire Equipment in Union City, PA. The total cost for the project was \$204,000. That is a huge amount of money, but much less than the price of \$358,000 to \$413,000 for a completely new unit. We had four prices for a new ambulance. Prices were from four different ambulance manufacturers that build a quality truck that will stand up to the heavy use and winters we get here in Northwest PA.

The Board of Directors is always doing all we can here at Perry Hi-Way to ensure our residents and workers have the best emergency services we can provide. We have worked in partnership with the Township Supervisors to make sure we have personnel to respond to emergencies. The Township provides significant financial support that is used to fund the paid staffing members.

While we have a bare bones paid staff, we are always looking for more volunteers; members to respond to accidents, fires, automatic fire alarms, and other calls for service. Volunteers also assist the paid crews on ambulance calls when additional people are needed for lifting or when an ambulance driver is on a serious medical or trauma response. Stop into the station Monday nights from 6 pm to 9 pm if you're interested in becoming a volunteer.



# On the Roads Again!

Throughout the winter, the crews plow snow, apply salt and anti-skid to the Township roads to make winter travel safe for township residents and visitors. Summit township has six excellent snow removal trucks that can be used to clear the roads. Residents are required to help the crew's work by **obeying the law** 

and removing their cars from public streets from November 1 to April 30. This allows the Road crew to do a nice job of cleaning the roads. If a vehicle is left parked in the road, we do have the right to tow it away at the owners expense, for everybody's safety. Summit Township has enough equipment to be able to keep up with the weather better than most anyone and, in our busy community, people have come to expect that.

Roads are a public right-of-way. Township standards are to clear the road from edge to edge or curb to curb to provide safe travel conditions and provide storage space for subsequent snowfalls. To do this sometimes requires multiple passes. We move the snow from the centerline to the edge of the road. This means that, until the street is completely clear, the plow will come back again. The plows are not lifted at driveways because this would leave snow

# WINTERTIME REMINDERS FOR RESIDENTS

It is hard to believe, but old man winter is knocking on our door, and we may have even experienced a few snowflakes in the air before the arrival of this newsletter. We want to remind residents of a few things to help keep them safe this winter season.

- Make sure you have working smoke detectors on each level of your home. The addition of a carbon monoxide detector also helps ensure there is no buildup of Carbon monoxide (CO). CO cannot be smelled, tasted, or detected by the human senses.
   Smoke detectors are available at the Township building and the Oliver Road fire station free of charge for Township Residents. We do not have CO monitors currently.
- 2. Have your chimney inspected and cleaned as needed for those burning wood or coal. A furnace cleaning and checkup is also a good idea for those without coal or wood heating.
- 3. After snow falls, make sure you take a few moments to brush off the house numbers and your mailbox numbers so we can find your address in the event of an emergency.

- 4. Remember, our trucks are wider and taller than most regular vehicles. When clearing your driveways, we need 10 ft wide spaces to drive and work in with our fire trucks. We also like to have 12 ft height clearance from tree branches, wires, or any other overhead obstructions.
- 5. Those who live near a fire hydrant, please take the time to clear a path to and around the fire hydrant after a snowfall. This will save us valuable time in getting water on the fire and hopefully lessen damage. We ask for a clear area around the fire hydrant to be 36".
- 6. Drivers, make sure you have an emergency kit in your car when you travel. Jumper cables, a blanket, a fold-up shovel, a tow strap, two bottles of water per person, a couple of non-perishable snacks, matches, a flashlight with fresh batteries, and even a bag of kitty litter or oil dry to help in a slippery situation. Other items to have in your vehicle are a winter hat, a warm pair of water-resistant gloves, and a spare set of warm clothes in case you get wet and need to change.


on the street; creating a hazard for drivers. Residents should be advised to wait as long as possible to shovel or clear at the end of their driveway. Also, when removing your snow, deposit the snow to the right of your driveway as you face the street. By doing this, when the plow returns, it will carry the snow you moved away from the driveway. Snow placed on the left side will probably end up back in your driveway the next time the plow makes a pass.

Not all of the streets or roads in the township are public. Some are private drives that are maintained by owners, homeowners associations, or developers. We also have many state roads in our Township which are maintained by PennDOT. We are not supposed to plow any part of the state roads, even if we think we are doing a favor. If we plowed a portion of a state road and then turned off onto one of our township roads, a motorist could be driving down the road on that plowed portion (thinking the road has just been plowed) then suddenly hit deep snow, causing them to have an accident where we turned off and did not finish.

Property owners and/or occupants are responsible for clearing snow and ice from adjacent sidewalks within 24 hours after the end of a snowfall. Owners or occupants failing to clear sidewalks may receive a citation, be fined and/or be responsible to reimburse the township for the cost of clearing the sidewalk.

Please drive safely, slow down, and allow extra time to reach your destination during winter weather events. This is the most effective way to prevent an accident. Thank you for your cooperation and happy holidays!

# **Summit Lions Club News**

Remember when the Lions would pick a day in the month of October to have a White Cane event, which was all the Lions would come out in their vests holding a hollow PCP pipe with a slit in the top, shaped in a candy cane design? This white cane represents the white cane a visionally impaired person might carry to walk safely around unattended. Caring individuals walking by the Lions would drop change and some dollars into the white canes and this money was used for Vision projects only. When first started, the money was used for school-age children who needed glasses whose parents could not afford them. This was back when insurance companies did not have vision care built into their plans. Those times have improved, but there is still eye care that is not covered by insurance companies that can be effective in the lives of individuals.

Age-Related Macular Degeneration, Diabetic Retinopathy, and other central vision loss conditions are eye conditions that make seeing difficult to manage everyday life. Imagine your central vision deteriorating, and your sight is like looking through out-of-focus binoculars all the time. You can manage some independence because you still have your peripheral vision, but your independence has greatly dropped. There are free apps that can go onto computers and phones that will look at a page and read it to these patients, but it is different from picking up a book and reading it. These computer and phone apps do not make watching TV any easier, so when the television is on, their enjoyment comes from listening to the story plot. 

# **SUMMIT TOWNSHIP SEWER AUTHORITY**

### **FOURTH QUARTER PROJECT UPDATES**

## 1. Oliver Road Gravity Sewer Lift Station and Force Main Project

Final design and permitting are complete for the re-routing of the sanitary sewer away from Peach Street. The project is moving toward the construction phase. The gravity portion north of I-90 is complete, and the sections south of I-90 are underway. There has been a delay in starting the bore beneath I-90 because the 6-inch bore guide tube did not arrive as expected on 10/6/25.

# 2. PA Small Water and Sewer Program Grant Application – White Birch Lane Sanitary Sewer Extension

The grant application has been submitted and is pending review by the Commonwealth Financing Authority. If awarded, this project will extend sanitary sewer service to underserved properties along White Birch Lane.

# 3. PA Small Water and Sewer Program Grant Application – Gartner and Harf Pump Station Rehabilitation

The Authority has applied for funding to modernize and rehabilitate the Gartner and Harf Pump Station. This project would replace aging components to ensure continued reliability and regulatory compliance.

## 4. Valley View Generator Replacement Project

The existing standby generator at Valley View is nearing the end of its service life. A replacement generator has been specified, and the Authority is using Costar's procurement options to cut costs. When completed, the backup generator will provide reliable backup power for critical operations during power outages. The Authority expects this project to be completed this year.

### 5. Speed Check Proposed Development – Intersection of Route 99 and Hershey Road

Developers have proposed commercial development at the intersection, requiring coordination with the Authority regarding sewer capacity and service availability. Preliminary evaluations are underway to determine infrastructure needs and costs. The timeline for this project is sometime in 2026.

### 6. 3300 Flower Road – Proposed 3-EDU Subdivision (E.J. Chernicky)

A subdivision plan for three additional new homes and possibly 6 sewer connections is under review. The Authority is assessing line capacity and service requirements to accommodate the proposed development.

### 7. Fairfield Avenue and Route 97

Infrastructure planning and evaluations are ongoing at this location to facilitate repairs to a manhole and piping that is for sanitary sewer backups. We anticipate bidding Spring of 2026.

Summit Township operates under a Municipal Separate Storm Sewer System permit, part of a statewide program to protect our local waterways from harmful pollutants. All stormwater that runs along our streets, driveways, and yards enters our waterways, ultimately running to Lake Erie or the Mississippi River Basin, untreated. This means that any garbage, yard waste like grass clippings and leaves, fertilizer, oil, pet waste, and more can all enter our water resources.

It is vital that we as a community do what we can to prevent these pollutants from entering our waterways. Keeping grass clippings and leaves out of the street protects pedestrians,

cyclists, motorists, and our waterways and ecosystems. Using a minimal amount of fertilizers, herbicides, and pesticides and not applying them with rain in the forecast can vastly reduce the impact on our rivers and lakes. A good rule of thumb is if you wouldn't want to swim in it or drink it, keep it out of the storm sewers.

This time of year, the falling leaves pose a challenge for residents. It is a violation of Summit Township's Open Burning Ordinance 2025-01 to conduct any open burning of leaf waste. Alternatively, mulching leaves benefits your lawn by adding natural fertilizer, improving soil moisture and structure, and suppressing weeds. It saves time and money compared to raking and bagging, while also creating a healthier, more resilient turf that requires less fertilizer. For garden beds, leaf mulch provides insulation, reduces erosion, and shelters beneficial insects like earthworms and pollinators. Please refrain from depositing leaves in or near storm ditches or catch basins, as this can decrease the effectiveness of the storm sewers and lead to flooding. Additionally, yard waste like grass clippings and leaves releases excess nutrients into the water as they decompose. Extra nutrients in the water accelerate the growth of algae and can cause an algal bloom, often looking like a mucky, green layer covering a pond or stream. An algal bloom depletes oxygen, harming aquatic life and disturbing the ecological balance of the entire stream ecosystem. Summit Township also provides curbside leaf pickup; more information can be found on our website.

Protecting our waterways starts at the individual level, and every step, no matter the size, can help keep our community and environment clean. Summit Township thanks you for your participation.

# **ENGINEER'S REPORT**

The Downs Drive Improvements Project was completed this past summer. Lindy Paving was the contractor for the project. The final cost for the project was \$321,631.02. Of that, \$250,000 was provided from the Commonwealth of Pennsylvania, Commonwealth Financing Authority, leaving the total cost to the Township at \$71,631.02.

As discussed previously, the Township received a \$400,000 grant from the Commonwealth of Pennsylvania, Commonwealth Financing Authority, to install sidewalks along the Peach Street Corridor. This project is currently in preliminary design, and we will be working with EMTA and PennDOT as we proceed to the final design. This project is still on track for a possible 2026 start to construction.

Finally, thank you to everyone who participated in the "Pick a Playground" survey for the Picnicana Playground project. We have narrowed it down to the top two vendors and are currently making revisions based on the input we received. We plan to review the final proposals in November and purchase the equipment before the end of the year to avoid the inevitable price increases. The Township has received \$200,000 from the DCNR's Keystone Recreation, Park & Conservation Fund for this project; we also applied for \$100,000 from Erie County's Greenways Program. Anticipated construction for this project is late summer and fall of 2026.

# PROTECT YOUR WATER LINES FROM **FREEZING**

Don't let winter weather catch you unprepared!

As temperatures begin to drop, now is the time to make sure your water lines are protected from freezing. Lines located in inadequately insulated crawl spaces, vacant structures, and under mobile homes are the most vulnerable and can lead to inconvenient outages and costly repairs.

# Here are a few tips to help ensure you are ready for winter:

- · Insulate around and apply heat tape to exposed water lines following the manufacturer's instructions. Make certain your heat tape is plugged in and working.
- Turn off water and disconnect hoses to all outside spigots.
- · In vacant structures, maintain a minimum temperature of 55 degrees or completely drain all water lines.

In the event you do experience a freeze, use extreme caution when using a heat source to thaw your lines. Never use a torch or open flame, as this could quickly become a fire hazard.

# **ADOPT-A-HYDRANT PROGRAM**

It's time once again to kick off our annual Adopt-A-Hydrant Program. We all know that guick access to a reliable source of water is critical when there is a fire. Unfortunately, so many fire hydrants are not accessible this time of year, forcing firefighters to spend valuable time shoveling them out during an emergency.

# **Leaf Raking & Yard Work Safety**

- · Lift properly: Bend at the knees, not the waist, to protect your back.
- · Pace yourself: Take breaks and stay hydrated.
- · Wear gloves and non-slip shoes to avoid blisters and falls.
- · Follow Township leaf disposal guidelines—avoid burning leaves.
- · Use ladders carefully when cleaning gutters—have a spotter present.

# **Turkey Frying Safety**

- · Always fry outdoors on a flat, stable surface.
- · Thaw turkey completely and dry thoroughly before frying.
- · Do not overfill with oil—check levels beforehand.
- · Keep a fire extinguisher nearby; never use water on grease fires.
- · Never leave the fryer unattended.

### **General Fall Home & Safety**

- · Have chimneys inspected and cleaned before use.
- · Test smoke and carbon monoxide detectors; replace batteries.
- · Drive cautiously—wet leaves can be as slippery as ice.
- · Check outdoor lighting for shorter days.
- · Wear reflective clothing when walking or biking at dusk.


### **Seasonal & Outdoor Hazards**

- · Disconnect spark plugs before servicing lawn equipment.
- · Be alert for deer, especially at dawn and dusk.
- · Watch for slippery sidewalks from wet leaves or early frost.
- · Keep bonfires small, contained, and supervised with water nearby.
